2,485 Reported Cases of COVID-19 in Anson County

As of Monday, April 19 the Anson County Health Department posted that Anson County had 2,485 reported cases of COVID-19. 39 of those cases were active and 56 deaths.

The Health Department is offering Covid vaccinations to all adults 18 and over. Anyone 18 or older can simply fill out the registration form and email it to:

covidregistration@co.anson.nc.us

or drop it off at the Health Department.

The county has set up a direct link to the registration form on the county government home page, *www.co.anson.nc.us*. You can also request the form via email at *covidregistration@co.anson.nc.us* or by calling the Health Department at 704-694-5188.

People who do not have an active email account can drop off the completed registration form in the drop box located at the front door of the Health Department, located at 110 Ashe Street in Wadesboro. Or they can call (704) 694-5188, press 1, and provide the information over the phone.

The NC Department of Health and Human Services (NCDHHS) reported that statewide as of Monday, April 19 there were 1,380 new cases of COVID-19, with 12,418 deaths and 1,096 hospitalized.

Statewide, as of Monday, April 12 there were 1,469 new cases of COVID-19, with 12,290 deaths and 904 hospitalized. April 5 there were 1,054 new cases of COVID-19, with 12,173 deaths and 907 hospitalized. March 29 there were 1,372 new cases of COVID-19, with 12,085 deaths and 873 hospitalized. March 1 there were 862,170 cases of COVID-19, 11,254 deaths, 10,291,482 tests and 1,219 hospitalized. February 1: 761,302 cases, 9,342 deaths, 8,908,258 tests, 2,781 hospitalized. January 4: 570,111 cases, 6,941 deaths, 7,119,201 tests, 3,192 hospitalized. December 7: 404,032 cases, 5,605 deaths, 5,678,794 tests, 2,373 hospitalized. November 2: 278.028 cases, 4,390 deaths, 4,116,019 tests, 1,146 hospitalized. October 5: 219,754 cases, 3,637 deaths, 3,188,371 tests, 971 hospitalized.

Recent history in Anson County: March 31, 2020: 1 case; April 28 - 23 cases (no deaths); May 26: 62 cases (1 death); June 22: 107 cases (2 deaths); July 27: 285 cases (2 deaths); August 31: 440 cases (4 deaths); September 28: 605 cases (4 deaths); October 26: 720 cases (9 deaths); November 30: 937 cases (14 deaths); December 31: 1,444 cases; (28 deaths); January 25: 1,957 cases (42 deaths); February 22: 2,258 cases (53 deaths); March 1: 2,298 cases (53 deaths); March 29: 2144 cases (56 deaths); April 5: 2,433 cases (56 deaths); April 12: 2,454 cases (56 deaths).


Commissioners Approve Land Use Plan

Free Roundtrip Transportation To Covid Vaccine Appointments

Underserved communities, including Anson County, can now call 1-844-771-RIDE for access.

Provided by RIDE UNITED NC, the free service supports communities of color, seniors, and uninsured individuals across North Carolina.

Despite the increasing availability of the COVID-19 vaccine in North Carolina, transportation access continues to be a barrier for underserved communities statewide. RIDE UNITED NC announced today that its call center is now available to support low-income North Carolina residents needing roundtrip transportation to COVID-19 vaccine appointments. Eligible individuals can call 1-844-771-RIDE starting this week. This service is available to citizens of Anson County.

The statewide initiative was launched last month by United Way of the Greater Triangle in partnership with Lyft, Blue Cross and Blue Shield of North Carolina (Blue Cross NC), and North Carolina Department of Transportation (NCDOT), in support of the North Carolina COVID-19 Public Health Coalition.

The call center has the capacity to support 1,500 calls per day for eligible individuals who do not have access to the Lyft app, those without bank accounts, and seniors. It will also work with NCDOT to supplement transportation needs in other communities. The call center is / has:

• Available Monday through Friday, 8 am to 8 pm

• Bi-lingual capabilities

• Open to those who are age 55+, uninsured, unbanked, and/or members of households considered low-income by the federal definition

The call center is made possible with support from Mako Documents, Pillar Consulting, and Wilcox Distributions. The entire RIDE UNITED NC program is made possible by investments totaling more than \$925,000 from Bank of America, Blue Cross NC, Blue Cross NC Foundation, Coastal Credit Union, Duke Energy, and Duke University and Duke Health. These donations support the North Carolina COVID-19 Public Health Coalition and will help provide rides statewide, including in Duke's home county of Durham.

"Free transportation services are essential for North Carolina to meet its goal of providing equitable access to COVID-19 vaccines and getting ahead of the pandemic," said Secretary Mandy Cohen. "We very much value the partnership and generosity of everyone who is contributing to RIDE UNITED NC."

RIDE UNITED NC also supplements existing efforts by the North Carolina Department of Health and Human Services (NCDHHS), NCDOT, and local transit agencies to provide public transportation services to vaccination sites.

"Ensuring equitable access to COVID-19 vaccines starts with providing convenient and free transportation options to all North Carolinians," said NCDOT Secretary Eric Boyette. "We commend United Way of the Greater Triangle and the many private and non-profit

School Board Meeting on April 26 to be Live Streamed

The Anson County Board of Education will hold their regular meeting on Monday, April 26. Closed Session will begin immediately after the opening of the meeting at 4:00 p.m. Open Session to the public will begin at 5:00 p.m.

The meeting will be live streamed on the Anson County Schools' YouTube channel for the public to view. To find the channel you can search YouTube for "Anson County Schools."

The meeting will be held in the Anson County Schools' Administrative Board Room, located at 320 Camden Road in Wadesboro.

Governors' orders on indoor gatherings will be enforced. Social distancing requirements will be enforced and masks will be required.

If the public wishes to sign up for public comment, they can go to the public comment link on the Anson Schools website at *www.ansonschools.org* to sign up. Public comment sign up will be from 4:15 to 4:45 p.m. on April 26.

• Beginner Class - May 7 & 8, \$175.

• Renewal Class - May 14 & 15 \$100.

To be eligible for these Lifeguarding courses the participant must be 15 years of age on or before the final scheduled session of this course. The participant must successfully complete the following:

1. Swim 300 yards continuously, using these strokes in the following order:

• 100 yards of front crawl using rhythmic breathing and a stabilizing, propellant kick. Rhythmic breathing can be performed either by breathing to the side or the front.

• 100 yards of breaststroke using a pull, breathe, kick or glide sequence.

• 100 yards of either the front crawl or breaststroke. The 100 yards may be a combination of front crawl and breaststroke.

2. Starting in the water, swim 20 yards using front crawl or breaststroke, surface dive 7-10 feet, retrieve a 10-pound object, return to the surface, swim 20 yards back to the starting point with the object and exit the water without using a ladder or steps, within 1 minute 40 seconds.

3. Tread water for 2 minutes without the use of hands.
