

#### Two-thirds of Anson County Bank **Branches Closed in the Last Decade**

Bill to address "banking deserts" is before the North Carolina legislature now

Sixty-seven percent of Anson County's brick-and-mortar bank branches closed over the last decade, mirroring a statewide trend. In the past 11 years, banks shut down 646 branches in North Carolina, or one of every four, with the largest share of closures coming in rural and less-wealthy counties. That's according to data from the Federal Deposit Insurance Corporation, which insures lenders and tracks bank locations.

Anson County is in the top 10 for closures, losing four of its six branches, according to the data. Anson County's lone credit union, State Employees' Credit Union (SECU),

has been there the whole time.

North Carolina is unfortunately a hot spot for these growing "banking deserts." The Federal Reserve Bank of Richmond said last year that North Carolina had the most banking deserts, by far, among the five states in the Richmond district. The phenomenon is most common in rural and lower-income counties. In "Tier 1" counties, which the North Carolina Department of Commerce defines as the most economically distressed in the state, banks closed nearly 40% of branches between 2013 and 2024. Anson County is a Tier 1 county.

The North Carolina General Assembly is considering a bill to address the dwindling financial services options available to rural North Carolinians by granting credit unions changes they seek that would allow them to expand. House Bill 187 would let credit unions offer financial services to residents who live in areas without a nearby bank branch. Under current state law, people typically must be part of a defined group – like working for the same employer – to qualify for membership at a credit union, limiting who credit unions can serve.

Credit unions and banks offer similar services like loans, checking and savings accounts, and credit cards. But unlike banks, credit unions are not-for-profit cooperatives. Every depositor is an equal part-owner of the credit union.

"For-profit banks are leaving rural parts of the state because there just isn't enough money there to justify maintaining branches," said Dan Schline, CEO of the Carolinas Credit Union League. "Credit unions have the right model to serve these communities because credit unions are beholden to their members, who are all part-owners. Credit unions want to open more branches in these underserved parts of the state."

This is the second time in the last few years credit unions have pushed for these reforms. Similar legislation passed the N.C. House of Representatives in 2023 by a wide margin, but it did not receive a hearing in the Senate before that legislative session ended in 2024.
