SPCC to Offer Medical Lab Assisting Course over Summer

South Piedmont Community College will offer a Medical Lab Assisting course this summer. The course could serve as a springboard into a medical laboratory or office, or into SPCC's Medical Assisting program.

Students in the class will master phlebotomy training and laboratory skills needed to conduct specimen testing in medical laboratory and office settings. Upon completion of the program, students will be eligible to take the Certified Medical Laboratory Assistant exam and the Certified Phlebotomy Technician exam. The training in the course, plus the certifications, will allow students to work in a laboratory setting in a hospital or physicians' office under the supervision of a medical laboratory technician or medical technologist. The expected salary range for graduates is \$7 to \$12 per hour.

Students who successfully complete the course may also apply to SPCC's Medical Assisting program and will be eligible to test out of Med 121, Med 130 and Med 150 to earn credit hours for those courses. Students must earn a B or higher on the test in order to receive credit. No credit hours will be awarded for the summer course.


