Cordero Little Busted for Armed Robbery in Burnsville

On Sunday, April 8 at 3:40 a.m. deputies with the Anson County Sheriff's Office were called to the Fast Shop on Highway 742 in Burnsville in reference to an armed robbery that had just occurred. At the scene deputies were advised by an employee that when he arrived to work and parked his car a subject wearing a hoody ap-



proached him pulled a firearm on him. The employee stated the *Cordero Little* hoodlum ordered him inside the store, and then the hoodlum took an undisclosed amount of cash. The employee the stated the man left, walking towards the Fire Department. After the hoodlum's departure from the store the employee called 911.

Once on the scene deputies began an investigation into the robbery. Surveillance footage of the incident was viewed by deputies and a possible suspect was identified. Deputies attempted to locate the suspect but were unable to make contact.

On Monday, April 9 deputies executed a search warrant at the residence of the suspect. Multiple items of evidence connecting the suspect to the scene were found and recovered. Suspect Cordero Levonne Little, 23, was arrested and warrants were served for Robbery with a Dangerous Weapon, Second Degree Kidnapping, Possession of Firearm by Felon, Possession with Intent Sell and Deliver Marijuana, and Possession of Cocaine. Little was placed in the Anson County Jail on a \$560,000 secured bond with a court date of April 23.

Sheriff Landric Reid stated that due to an accurate description of the suspect and video footage obtained from the store, his officers were able to develop a suspect and make an arrest. Sheriff Reid said, "I would like to thank my officers for their professionalism and dedication in the quick response in apprehending the suspect."

Columbus McKinnon to Expand Wadesboro Operations, Investing \$5.4 Million and Creating 19 Jobs

The Anson Economic Development Partnership (AnsonEDP) is pleased to announce that Columbus McKinnon Corporation (NASDAQ:CMCO), a leading designer, manufacturer and marketer of material handling products, technologies and services, will expand operations in Wadesboro, creating 19 jobs. The company plans to invest \$5.4 million in its Anson County facilities, enabling the introduction of its STAHL line of crane products into the North American market. The average wage of the new positions will be \$49,897, which is above the Anson County average wage of \$32,584.

Columbus McKinnon, with headquarters in Getzville, New York, enjoys a rich 140-year tradition of excellence providing products and services such as hoists, actuators, cranes, and lifting and rigging tools. Last year, the company completed its acquisition of STAHL CraneSystems, a well-known brand of hoists and crane components based in Germany. The Anson County expansion will position the company to manufacturer STAHL products in North Carolina, introducing the line directly into the North American market.

Anson County and the Town of Wadesboro provided Industrial Tax Grants of \$135,000 and \$92,000, respectively, in support of the project. The Industrial tax Grant program offers new and expanding industries the opportunity to receive back a portion of its paid property taxes on new investment in the form of a grant. Additionally, a performance-based grant of \$60,000 from the One North Carolina Fund and a \$60,000 Rural Division Building Reuse Grant will help facilitate the expansion.

"AnsonEDP was pleased to work with Columbus McKinnon on this expansion, and to facilitate the support of the County Commissioners and Town Council to make it happen here in Wadesboro," said AnsonEDP's Executive Director, John B. Marek. Randi Rivers and Jaylan Smith charged in armed robbery in Hamlet

On Tuesday, April 17 an armed robbery occurred at a convenience store in Hamlet, NC. An attempt to locate the robber was issued to the Anson County Sheriff's Office describing the vehicle and suspect that had committed the robbery. Deputies with the Anson County Sheriff's Office located and stopped the vehicle on Highway 74 West near Fire Tower Road in Lilesville. Two suspects were in the vehicle, along with a weapon matching the description of the one that had been used in the robbery.

Contact was made with Hamlet Police Department and they responded to the scene to assist Anson deputies. The suspects were then turned over to officers from Hamlet Police and transported back to Hamlet.

Randi Sa'mone Rivers, 20, and Jaylan Deshawn Smith, 17, both of Wadesboro, were each charged with one count of Robbery with a Dangerous Weapon and Conspiracy to Commit Robbery with a Dangerous Weapon. Both suspects were placed in the Richmond County Jail. Smith was placed under a \$50,000 secured bond. Rivers was also served with an indictment on felony charges in Anson County. Court records show she is facing four counts of felony conspiracy, one felony count each of breaking and entering, larceny after breaking and entering, attempted first-degree burglary and a misdemeanor count of filing a false report at a police station. She was jailed under a total \$85,000 secured bond.

On Monday, April 16 a breaking and entering and larceny was reported on Highway 218 in Polkton. When a description of the vehicle involved was given to deputies, that vehicle was known to the deputies from previous incidents in Anson County. Arrest warrants had already been issued on Rivers for the breaking and entering in Anson County prior to the robbery in Hamlet. After the April 17 arrest of Rivers and Smith, deputies went to the Hamlet Police Department and interviewed the suspects involved in Hamlet robbery. Rivers and Smith were also charged with Felony Breaking and Entering and Larceny after Breaking and Entering by Anson County Deputies. Imisa Smith of Wadesboro was also charged with Felony Breaking and Entering, Felony Larceny after Breaking and Entering and Enteri

Sheriff Landric Reid said, "I would like to thank the Richmond County Sheriff's Office and Hamlet Police Department for their accurate and detailed description of the suspects and their vehicle. I also commend our Anson County officers for their professionalism demonstrated in the quick apprehension of the suspects."

Charlotte Man Busted with 3 Pounds of Pot at Polkton Checkpoint

On Friday, April 20 deputies from the Anson County Sheriff's Office were assisting the Polkton Police Department with a multi-agency traffic checkpoint in the city limits of Polkton. A newer model Chevy Silverado truck approached deputies at the intersection of Highway 218 and Williams St, reet, and when a deputy asked the driver for his license he noticed that the driver was very nervous. The deputy also noticed a smell of marijuana coming from inside the vehicle. The deputy had the driver pull off the main road to a safe location and requested a K-9 to conduct a sniff of the truck. After the K-9 gave a positive indication to the presence of drugs the driver admitted that there was marijuana in the vehicle. A search was conducted and over 3 pounds of marijuana was found, along with a large amount of U.S. Currency and a firearm in the passenger area.

The suspect, Demitrius Adrian Ross, 34, from Charlotte, was arrested and charged with Possession With intent to Sell and Deliver Marijuana, Felony Possession Of Marijuana, Possession Of a Firearm by a Convicted Felon, and Possession Of Drug Paraphernalia. Ross was placed in the Anson County Jail under a secured bond.

The investigation was conducted by the Anson County Sheriff's Office and Polkton Police Department. Sheriff Reid would also like to thank the K-9 officer and his partner from the Norwood Police Department for their assistance in this case.
