#### 2,499 Reported Cases of COVID-19 in Anson County

Vaccines are available. All Ansonians 18+ urged to get vaccinated. Only 22% are fully vaccinated.

As of Monday, April 23 the Anson County Health Department posted that Anson County had 2,499 reported cases of COVID-19. 42 of those cases were active and 56 deaths. Health Director Fred Thompson, PhD gave this **update,** "Here are some important updates about operations at the Health Department and Covid vaccinations.

We are currently offering the Moderna Covid-19 vaccine

to all adults 18 and over on Tuesdays and Thursdays at the EMS Center on Country Club Road. We have capacity for about 100 first doses and 100 second doses each day. Anyone 18 or older can simply fill out a registration form and email it to: covidregistration@co.anson.nc.us or drop it off at the Health Department. Once we receive the registration form we will contact the individual to schedule their vaccination.

The county has set up a direct link to the registration form on the county government home page, www.co.anson.nc.us. You can also request the form via email at covidregistration@co.anson.nc.us or by calling the Health Department at 704-694-5188.

People who do not have an active email account can drop off the completed registration form in the drop box located at the front door of the Health Department, located at 110 Ashe Street in Wadesboro. Or they can call (704) 694-5188, press 1, and provide the information over the phone.

Thompson continued, "Unfortunately, we have hit a wall in our Covid vaccinations. We only have 32 first doses scheduled for today (Tuesday, April 27) and only 7 scheduled so far for this Thursday. Only 27% of Ansonians have received their first dose and only 22% are fully vaccinated. I want to encourage everyone 18 and over to get vaccinated. The vaccines are safe and effective, and getting vaccinated is the best way to protect yourself and all that ou are in close contact with every day.

While the number of new Covid-19 cases has come down, we still had 25 new cases last week. Lets work together as a community to increase our vaccination rate and drive the number of new cases in Anson County to zero. As always, please reach out to us with your questions.'

The NC Department of Health and Human Services (NCDHHS) reported that statewide as of Monday, April 26 there were 1,334 new cases of COVID-19, with 12,560 deaths and 1,067 hospitalized.

Statewide, as of Monday, April 19 there were 1,380 new cases of COVID-19, with 12,418 deaths and 1,096 hospitalized. April 12 there were 1,469 new cases of COVID-19, with 12,290 deaths and 904 hospitalized. April 5 there were 1,054 new cases of COVID-19, with 12,173 deaths and 907 hospitalized. March 29 there were 1,372 new cases of COVID-19, with 12,085 deaths and 873 hospitalized. March 1 there were 862,170 cases of COVID-19 11,254 deaths and 1,219 hospitalized. February 1 761,302 cases, 9,342 deaths and 2,781 hospitalized. January 4: 570,111 cases, 6,941 deaths and 3,192 hospitalized. December 7: 404,032 cases, 5,605 deaths and 2,373 hospitalized. November 2: 278.028 cases, 4,390 deaths and 1,146 hospitalized. October 5: 219,754 cases, 3,637 deaths and 971 hospitalized.

## **Governor Cooper Outlines Timeline** for Lifting State's COVID-19 Restrictions

As vaccinations continue and trends stabilize, NC will lift mandatory social distancing, capacity, and mass gathering restrictions by June 1

Governor Roy Cooper and North Carolina Department of Health and Human Services Secretary Mandy K. Cohen, M.D. have laid out a timeline for lifting current pandemic restrictions. With stable trends and continued vaccination success, the state expects to lift mandatory social distancing, capacity, and mass gathering restrictions by June 1. The Governor plans to issue an executive order next week outlining safety restrictions

'Each shot in an arm is a step closer to putting this pandemic in the rearview mirror, said Governor Cooper. "North Carolinians have shown up for each other throughout this entire pandemic and we need to keep up that commitment by getting our vaccines.

North Carolina continues to focus on distributing vaccines quickly and equitably. This fast and fair approach to getting shots in arms is the best way to beat this pandemic, protect one another, boost the economy and make it possible for restrictions to be lifted. To date, the state has administered over 6.5 million vaccines. 46.9 percent of adults

are at least partially vaccinated, and 35.1 percent are fully vaccinated. More than 76

percent of people 65 and older have had at least one shot. With vaccine now widely available across the state - often with no wait for an appointment, all North Carolinians 16 and older can plan to take their shot. The state anticipates lifting the mask mandate and easing other public health

recommendations, once two thirds of adult North Carolinians have received at least one vaccine dose and if trends remain stable. 'We are at an exciting moment. We now have enough vaccine for everyone," said

Secretary Cohen. "If you are 16 and older, it is your turn to join the more than 3.6 million North Carolinians who have already taken their first shot. It's up to you to get us to the two thirds goal as quickly as possible so we can live with this virus and begin to put this pandemic behind us.

Gov. Cooper and Sec. Cohen urged North Carolinians continue to get vaccinated and exercise good judgment even when restrictions are lifted. Businesses should continue to follow voluntary health recommendations and North Carolinians should continue to take safety measures in order to boost the economy, keep children in The Centers for Disease Control and Prevention (CDC) and the Bureau of Labor

Statistics (BLS) released statistics indicating that North Carolina is among the states with the fewest deaths and fewest job losses per capita.

State health officials are continuing to monitor the presence of COVID-19 and its more contagious variants in North Carolina, which is why it is important to continue to follow the state's mask mandate and continue to practice safety precautions, including the Three Ws—wear a mask, wait 6 feet apart, and wash hands often.
