#### **Community Health Assessment**

The Anson County Health Department, in cooperation with Anson Community Hospital, is conducting a Community Health Assessment of the entire county. The Health Assessment is conducted every four years to qualify the Health Department and the county for state funding and support. The CHA is the foundation for improving and promoting the health of our community. The role of this assessment is to identify factors that affect the health of our population and to determine the availability of resources within our county to adequately address these factors.

The Health Department has contracted with the consulting firm Leverage & Development, LLC to do most of the research. Don Altieri, Lois Crumpler and Janet Christy, representatives of Leverage & Development, LLC, will be contacting health care providers and organizations related to health and wellness to gather the necessary data. Anson County Health Department and Anson Community Hospital ask that individuals cooperate with the consulting firm's requests for information needed to complete the Assessment.

As part of the Assessment, the Health Department is conducting an opinion survey in which our citizens provide their input. Health Department employees will be at various venues in Anson County with these surveys asking for our citizens' input. ### **Boating Safety Campaign Resumes**

The "On the Road, On the Water, Don't Drink and Drive" safety campaign is back. After a successful inaugural effort in 2011, the multi-agency campaign will resume this summer. A news conference will be held 11 a.m., May 22, at Upper Barton Creek Boating Access Area on Falls Lake, near Raleigh, to kick off the campaign.

North Carolina sets the same limits for vessels and vehicles: Any driver with a blood-alcohol concentration that meets or exceeds .08 or is appreciably impaired by alcohol and/or drugs is subject to arrest.

But perhaps more than anything, the safety campaign is about education. "We can't arrest our way out of the problem of impaired driving. This is a high visibility campaign, being very much about awareness and personal responsibility," said Lt. Todd Radabaugh with the N.C. Wildlife Resources Commission. "We want drivers to understand and accept the responsibility of safety - on the road and on the water - for themselves and others."

The "On the Road, On the Water, Don't Drink and Drive" campaign combines law enforcement resources to ensure that everyone can travel safely on highways and waterways during summer. Officers will conduct sobriety checkpoints and special saturation patrols during busy holiday periods, combined with special messaging strategies to increase awareness of the dangerous consequences of impaired driving. Leading the campaign are the N.C. Wildlife Resources Commission, responsible for enforcing boating regulations, and the State Highway Patrol, providing for highway safety.

Joining the safety campaign are the Alcohol Law Enforcement division, local police and sheriff's departments and Forensic Tests for Alcohol branch, which is providing six mobile breath-alcohol testing units. Each mobile unit is equipped with alcohol screening devices, computers and communication work stations, as well as a magistrate office and other necessary equipment and supplies for processing impaired suspects.

The state chapter of Mothers Against Drunk Driving is promoting and supporting the safety campaign through additional outreach and education.

There are more than 200 sworn, full-time wildlife officers across the state who patrol 5,000 square miles of inland streams, rivers, lakes and coastal waterways and instruct certified boating safety education courses. The public can assist them by reporting boating violations to 1-800-662-7137.

10th Anson County Sheriff's Citizens Law Enforcement Academy Graduates

They saw a display of illegal drugs, watched videos of undercover drug buys, participated in a mock crime scene, saw Sheriff's Office vehicles and firearms and equipment and actually fired weapons on the Sheriff's "Ride-A-Long" Program. ## Take a Kid Fishing During National Fishing and Boating Week 2012

Take a kid fishing and help instill a lifelong love of the sport at one of more than 40 free kids' fishing events held in celebration of National Fishing and Boating Week 2012. The N.C. Wildlife Resources Commission, in cooperation with Neuse Sport Shop, Trout Unlimited, Bass Pro Shops and the U.S. Forest Service, is supporting these fishing events, which are scheduled from late May through early June throughout the state.

Young anglers registered at any fishing event are eligible to enter a statewide drawing for prizes. The grand prize is a lifetime sportsman license, which includes freshwater and saltwater fishing privileges, as well as hunting privileges, donated by Neuse Sport Shop, located in Kinston. The first prize is a lifetime freshwater fishing license, donated by the N.C. State Council of Trout Unlimited. Bass Pro Shops is donating 50 fishing-related prizes, such as tackle boxes, rod-and-reel combos and fishing line, while the Wildlife Commission is donating another 100 prizes — any of which would be a perfect addition to a young angler's tackle box.

Local sponsors for many events will provide prizes and gifts to registered participants as well. The Wildlife Commission will conduct the drawing for prizes at the end of June and will publish a list of winners on its website, *www.ncwildlife.org*, in early July.

To give kids a better chance of catching fish, the Wildlife Commission will stock fish at many of these sites before the events - from trout in the mountains to channel catfish and bluegill in Piedmont and coastal public waters.

More than 2,500 children are expected to participate in this year's events, many of whom will be first-time anglers.

"These fishing events are great opportunities for new anglers to learn more about fishing because there will be volunteers on hand to teach them the basics and help them reel in fish," said Bob Curry, chief of the Wildlife Commission's Division of Inland Fisheries. "The more positive their initial fishing trip is, the more likely they will make fishing a lifelong hobby, which is one of the goals of National Fishing and Boating Week."

### Individual Income Debt Payment Program Extended until May 31

Due to continued high levels of interest in the Individual Income Tax Debt Payment Program, the North Carolina Department of Revenue is extending the time to participate in the program to May 31. This time limited program originally ended April 30, and was created to help individuals catch up on unpaid taxes, while benefiting from certain penalty and fee waivers.

In exchange for a taxpayer paying the balance of tax and interest owed by May 31, NCDOR will waive certain unpaid, civil penalties and fees, which could save individuals as much as 35 to 40 percent. Participating taxpayers can also avoid forced collections actions such as garnishments, liens, and levies.

There are currently more than 29,000 taxpayers participating in the program. Under the terms of their agreements with the department, they are saving more than \$18 million in penalty and fee waivers.

"We have seen such high interest in this program and believe this extension will benefit many more North Carolinians who are facing tough financial hardships, said Secretary of Revenue David Hoyle. "We want to make it easy for our citizens to work with state government and move everyone forward in this economic recovery."

Any taxpayer who has properly filed their tax returns with NCDOR and has received a notice for unpaid taxes prior to January 1, 2012, may participate. A taxpayer who has not filed a return, does not currently have an outstanding tax liability or is the subject of an ongoing criminal investigation or prosecution is not eligible.

Members of the State Employees' Credit Union may also qualify for a low-interest loan program to pay their unresolved tax balances.
