### **Town of Wadesboro Awarded Grants for Thread Trail Project**

Last week, the Carolina Thread Trail Governing Board awarded \$450,300 in implementation grants for projects along the Thread Trail to the Town of Wadesboro, the Gaffney Board of Public Works, the City of Shelby, City of Salisbury, Catawba Lands Conservancy, City of Lincolnton and the Town of McAdenville.

Implementation grants provide funding to communities and nonprofit organizations to assist with trail corridor planning, land acquisition, construction and trail amenities. There are currently over 260 miles of Thread Trail and 170 miles of Thread Trail blueway open to the public throughout a 15-county region in North and South Carolina. These grants were awarded in May as part of the Thread Trail's bi-annual grant cycle. To date the Thread Trail has awarded more than \$6 million in catalytic grants to communities.

Wadesboro received two grants in the amounts of \$85,000 and \$20,000. The funds will be used to complete a trail corridor planning study that will identify the preferred route options for the proposed 1.7 mile Wadesboro Greenway. Once the trail corridor planning effort is complete and a preferred route established, the Town will work to acquire trail easements that will facilitate a 1.7 mile trail that will provide linkages to the existing Wadesboro Park Trail and other key destinations within the community.

The other grants awarded, community information and

the use of the grants follow:

 GAFFNEY BOARD OF PUBLIC WORKS, GAFFNEY, S.C. (CHEROKEE COUNTY) - \$150,000. Funds from this grant will be used to cover the construction costs of approximately 4.5-5 miles of natural surface trail and necessary bridges for completion of the Overmountain Victory Historic Trail at Lake Welchel.

• CITY OF SALISBURY, N.C. (ROWAN COUNTY)

\$132,000. This funding will be used for the design and engineering for expansion of the Salisbury Greenway from Catawba College to Kelsey Scott Park. This will connect with the Thread Trail segment from Kelsey Scott Park to Jake Alexander Blvd. This project will add approximately 1.6 miles of trail to the system. CITY OF SHELBY, N.C. (CLEVELAND COUNTY)

\$45,000. The grant will fund the widening of the First Broad River Trail from 5' to 10' to accommodate the high volume of trail users. This 1.5-mile trail runs along the First Broad River from the trailhead at Grover Street to south

of W Dixon Boulevard.

 CATAWBA LANDS CONSERVANCY, LINCOLNTON, N.C. (LINCOLN COUNTY) - \$10,800. This grant funding will be used to cover the required transaction costs associated with the Masspoag Property in Lincolnton, NC, a 14.5-acre property that will be home to part of the 1.5-mile segment of trail that will serve as the connector between the South Fork Rail Trail and Marcia Cloninger

 CITY OF LINCOLNTON, N.C. (LINCOLN COUNTY \$5,000. These funds will cover the costs for the research needed to clarify all ownership rights and determine the status of the railroad corridor and other properties in the missing link section between the Marcia Cloninger Rail Trail and South Fork Rail Trail.

 TOWN OF MCADENVILLE, N.C. (GASTON COUNTY) - \$2,500. The grant will be used to fund the purchase of a trail easement through two properties along the South Fork River in McAdenville which will facilitate a critical linkage for the Thread Trail's South Fork corridor connection between Cramerton and McAdenville.

## **Norwood Police Officer Fights Off Driver After Being** Pulled Partway into Moving Car, Apprehends Suspect

Officer was dangling out of speeding car, ended with crash in Anson County

After pulling over a car for a defective headlight, a Norwood Police Otticer. Detective Michael Hodgson, was assaulted by the driver. Timothy Robinson, and pulled into Robinson's car as Robinson sped away with the door still open. The officer was reportedly able to hold on with his legs dangling outside of the car at speeds estimated at 80 to 90 miles per hour.

The incident took place about 9 p.m. on Friday, May 25 during an operation focused around infractions and general observations by the Norwood Police Department along with the North Carolina Highway Patrol, and the Stanly County Sheriff's Department. Hodgson pulled Robinson in front of Norwood Elementary School. back turned to the driver-side door and he charges me, slams me up against the car, jumps in the car. He grabs my shirt and pulls me," Hodgson said. Once Robinson had pulled Hodgson partially into the car door and drove off, Hodgson held on while Robinson continued to assault him, officials said.

"He was trying to physically harm me and/or kill me. I think he was trying to kill me," Hodgson told Norwood officials. "He had to have been rolling at least 70, 80, 90 miles an hour with my legs dangling out of the car.'

"The suspect told Detective Hodgson, 'I'm going to kill you tonight and I'm going to kill myself and I'm going to run us off the bridge," Norwood Police Chief James Wilson said. When the officer was able to get inside the moving car, he and the driver were kicking, punching and fighting as the car kept moving recklessly down the road. According to a Norwood town official, the suspect told Det. Hodgson that when they get to the bridge, they would both die. As the car got closer to the Rocky River bridge, south of Norwood, the driver, Robinson, appeared to be intentionally directing the vehicle into the bridge Hodgson was able to wrestle the steering wheel left as they approached the bridge, keeping the car on the road. Once past the bridge and into Anson County, the car turned onto on Highway 52 where the officer used a Taser on Robinson, and was able to pull the steering wheel right and force the car off of the road. The car went over an embankment, briefly going airborne, clipped at least one tree and crashed in a backyard with both airbags deployed. The suspect tried to flee from the scene, but Hodgson pursued and tackled him. Another officer arrived and intervened to assist Hodgson. Hodgson was transported to the hospital but was later released.

Robinson faces charges of assault to a law enforcement officer with a firearm, attempted first-degree murder, injury to personal property, resisting a public officer, kidnapping, and trafficking in cocaine, among others. He was in jail for less than 12 hours. He paid more than \$112,000 to bail out, which is 15 percent of his \$750,000 bond. Norwood Town Administrator John Mullis said, "Last night Norwood could have too

been mourning the loss of another dedicated law enforcement officer. By the grace of God, the event did not turn tragic. After interviewing Detective Hodgson I am absolutely amazed at his thought processes as we ran through the previous event together. Detective Hodgson was placed into the event and had to make a multitude of decisions during the event that most likely saved his life as well as the life of the suspect." This incident happened on the same day a chase between a deputy and a man who

tried to flee from a traffic stop in Cabarrus County ended in a deadly crash.
