#### Two Corpses Found in Abandoned F&M McLendon Funeral Home

A confession in the courtroom last Wednesday by Mary McLendon, former owner and operator of F&M McLendon Funeral Home in Wadesboro, resulted in the discovery of two corpses abandoned for at least two years in the F&M building, located on Highway 109 in Wadesboro. The building has been vacant for several years. After that gruesome discovery, law enforcement

officers obtained a warrant to search a 30 acre parcel of land that belongs to the McLendon family, but nothing was found. McLendon was on trial last week for failing to cremate the remains of Marshall Lee Allen, and was found guilty of Obtaining Property by False Pretenses. She was sentenced to 6-17 months in prison. The charges were brought against McLendon in 2012, based on allegations that she had accepted a payment of \$1,500 from Allen's family for the cremation, but never

During the trial on Wednesday, June 4 the judge compelled McLendon to reveal where Allen's body was located, so she accompanied officers from the Wadesboro Police Department and Anson Sheriff's Office to the F&M building where Allen's body was found. According to WPD Captain Brandon Chewning, "The body was very decomposed and could not be identified. We then

obtained a search warrant and searched further, finding another decomposing body in the building. We contacted medical examiner officers who picked up the two bodies. They identified the first body as Allen's. His family was notified.' "The original body was found in a back room wrapped in clothes in a casket. The second body was lying on a table,

Wadesboro Police Chief Thedis Spencer said. This past weekend officers searched a 30 acre parcel of McLendon property on Clemmons Road in Lilesville for several

performed the service. The body had never been recovered.

days. Cadaver dogs were used during the search of the property and four acre pond, but nothing was found. As of press time law enforcement is awaiting the identification of the second body found in the funeral home building.

Captain Chewning said, "We are waiting for medical examiners to identify the second body we found last week. McLendon nas not revealed that information and is not cooperating at this point. Charges are pending on second body after identification. These will be felony charges, and McLendon will face additional jail time if she is found guilty." The Wadesboro Police Department expressed their gratitude for help from the Anson County Sheriff's Office, the SBI, the

Lilesville Fire Department, Anson County Emergency Management, the NC Forestry Service, NC Wildlife, the Favetteville Police Department and the NC Emergency Management Task Force 5.

McLendon's troubles began with a separate situation in November 2010, after Sheriff's deputies discovered three corpses n her funeral facility that had not been cremated or buried. The N.C. Board of Funeral Services said McLendon told a law enforcement officer the bodies were people who had died that month. In fact, the board said, one of the deceased, Richard Bennett, had died five months earlier. Another, Willie Mae Odom, had been dead for six weeks, the board said. And Larry Kendall had died about a month earlier, according to the board's letter.

McLendon denied the claims, blaming the problem of the unburied bodies on the foreclosure her funeral home was facing. At that ime she said, "I've been painted as a business person that has done wrong. Nobody has told the truth about how I conduct business. Those bodies were sent to another funeral home for cremation and funerals.

In 2012 McLendon lost her operating license because of those charges.

# Town of Wadesboro Responds to Sweepstakes Article

Last week The Express ran an article about two sweepstakes operations that were busted by the Sheriff's Office on May 29. Ronnie Burr, Timothy Burr and Amanda Kessler were arrested in the raids. In the article Sheriff Tommy Allen said, " do not understand how the Wadesboro Town Council could authorize the issuance of a business license (as they voted in their April meeting) to an operation that by statute is illegal. I don't understand their thinking when the law is very clear. Wadesboro Town Manager Alex Sewel responded to that article. "It's always a pleasure to work with Sheriff Allen and his

office. The Town certainly understands and respects the Sheriff's decision as a law enforcement official. For the Town's position on the matter, please see below an excerpt from UNC School of Government's Business License Expert Chris McLaughlin."

McLaughlin's article states, "Should cities be issuing privilege licenses to new internet sweepstakes businesses? Yes, if the business pays the required tax. A privilege license is simply a receipt demonstrating payment of a privilege license tax. It is emphatically not the city's stamp of legal approval for a particular business. From a tax perspective, it's important to remember that it's not the job of the privilege license tax collector to

determine if a particular internet sweepstakes business is legal or is banned by GS 14-306.4. That's the job of the police or the sheriff or the district attorney. It seems prudent for the privilege license tax collector to remind a new applicant of the ban on internet sweepstakes and

that the city will not refund any portion of the tax if the applicant's business is later shut down by law enforcement (assuming, of course, that the city's tax ordinance does not authorize such refunds). But I do not think the privilege license tax collector has the authority to require the applicant to somehow prove that its business is legal before issuing a privilege license. Nor do I think that a city may conclude that all internet sweepstakes are illegal and therefore refuse to issue any new

privilege licenses for these businesses. As the many acquittals across the state under G.S. 14-306.4 prove, it's clearly possible for these businesses to utilize systems that escape the reach of the sweepstakes ban." Sewell concluded, "Similarly, the Town does not take the position that internet sweepstakes businesses are legal. Each apolicant for a Wadesboro Privilege License signs a form which contains the following language: 'The issuance of this privilege

icense is conditioned upon the applicant conducting business exclusively in accordance with Federal, North Carolina, and local laws, including all laws regulating gambling and sweepstakes machines. By issuing this document, the Town of Wadesboro offers no opinion as to the legality of an applicant's business.' Wadesboro Farmers Market is Now Open

The N.C. Department of Transportation has awarded \$3.2

million in repaving in Anson County. It is part of about \$21 million worth of repaving work in Mecklenburg, Cabarrus, Union and Anson counties. Over \$82.5 million worth of projects has been awarded statewide in recent weeks by the DOT. The contracts went

to low bidders, officials said. Work on these contracts can start July 1 and must be com-
