#### Start of Hurricane Season, North Carolinians Urged to Stay Safe

Governor Josh Stein, along with Director of Emergency Management Will Ray, Attorney General Jeff Jackson, First Sergeant Chris Knox of the North Carolina Highway Patrol, and Colonel Patrick Henderson of the North Carolina Army National Guard held a briefing to provide updates and guidance at the start of hurricane season. Governor Stein urged North Carolinians to have a plan in place in case of emergency and shared resources to help people prepare and stay safe.

"As our state braces for hurricane season, I encourage North Carolinians be aware of emergency management warnings and resources so that they have a plan to stay safe in case of an emergency," said Governor Josh Stein. "Emergency Management continues to prepare amidst uncertainty on the federal level – we must stay the course and do everything in our power to keep North Carolinians safe no matter what happens in Washington, DC."

"Hurricane season has begun and there are steps to be taken to protect yourself, your family, and your property if a hurricane or tropical weather does strike," said North Carolina Director of Emergency Management Will Ray. "Remember to put together an emergency kit, have multiple avenues from which you can receive emergency announcements, and take the steps needed to protect your home."

The State Emergency Response Team has begun preparations for the 2025 hurricane season by reviewing lessons learned from previous storms as well as polices and procedures and exercising key processes to ensure all resources are available to local communities should a storm impact the state. The focus of the State Emergency Response Team is to support local emergency management and first responders, but it is imperative that all North Carolinians take the time to prepare their household for tropical weather. Preparedness builds resilience.

Last month Governor Stein published an op-ed about smart ways to reform FEMA in USA Today as North Carolina braces for hurricane season. The Governor outlines his recommendations to reform FEMA, including focusing on permanently rebuilding homes and businesses, implementing a common application for survivors to apply for aid, and moving away from reimbursement programs. There is much room for improvement in FEMA, but abolishing FEMA exacerbates the problem as we enter another hurricane season.

# Make sure your family is prepared before disaster strikes. Below are some

things you can do immediately to get prepared:
Put together an emergency kit, including non-perishable food and water (1 gallon per person per day) for 3 to 7 days, a battery-powered or hand crank radio or a National Oceanic and Atmospheric Administration Weather Radio with extra batteries, and prescriptions and over the counter medication.
Be aware of any unique needs for babies, elderly, or

disabled members of your household, as well as pets.
Have multiple ways to receive severe weather warnings such as the weather alert app on your phone, a National Oceanic and Atmospheric Administration Weather Radio,

or local TV news. • Build an emergency plan in case you and your family need to evacuate, including a plan for communication. Have printed copies of family members' phone numbers, social media handles, email addresses, and important medical information in case mobile devices die. Plan where you will meet if you are separated from your family and have copies of important papers such as birth and adoption certificates, driver's licenses, or military ID's.


• Protect your home by preparing a full list of personal items to help with insurance settlements or tax deductions. • Be sure you know how to shut off your utilities safely

We've done the work, we've met the American Welding Society's rigorous standards, and now, not only are we delivering the very highest juality welding education, we're also able to test welders from throughout our region. If you are interested in a welding career, your first stop should be South Piedmont Community College," said Vice President of Business & Workforce Solutions Chris Rivera. To earn the accreditation, South Piedmont had to meet specific requirements for personnel, equipment, and procedures. Having met those requirements, South Piedmont is now able to test and qualify welders for the American Welding Society's Certified Welder certification. The Certified Welder certification opens up a lot of doors," said Director of Applied Technical Programs Aaron Wulk, who oversaw South Piedmont's accreditation effort. "When you earn your CW, it validates that you are capable of meeting the standards of the welding profession, that you can make a good weld and meet code, that you have proof that you can do the job. When you earn your CW, you can be added to a national registry of certified welders; a very small percentage of welders are on the national registry. It means you're one of the best." With South Piedmont being an accredited test site, not only can students be assured they are getting a high-quality welding education, but they can also complete their CW at their home program. "It's more convenient for students, and they're going to be in a setting where they're comfortable, using equipment they're familiar with," Wulk said. #### Governor Stein Highlights DMV Challenges, Calls for Increased Investment

Governor Josh Stein has joined Secretary of Transportation Joey Hopkins and DMV Commissioner Paul Tine to highlight North Carolina's ongoing DMV crisis and call for cross-government partnership to improve the customer experience.

"Hundreds of thousands of North Carolinians each year visit the DMV, and they need to be able to take care of their business in a timely manner," said Governor Josh Stein. "We are tackling this problem head-on, and Secretary Hopkins, Commissioner Tine, and I are committed to working with our legislature and Auditor Boliek to make the DMV work better for everyone."

"Every North Carolinian on our roads will need to interact with the DMV at some point, so we have a responsibility to get it right," said Department of Transportation Secretary Joey Hopkins. "I am pleased to see Commissioner Tine hitting the ground running."

"Since my appointment a month ago, I have dedicated myself to meeting with DMV customers and team members to learn more about the challenges our state is facing," said DMV Commissioner Paul Tine. "While we have begun raising pay for examiners, simplifying the website, and finding opportunities to get more people through offices this summer, we know there is much more work to be done to ensure a positive experience for customers and team members alike."

Governor Josh Stein and the NC Department of Transportation announced Paul Tine's appointment as Commissioner of the DMV on April 30. Commissioner Tine is working to improve North Carolinians' experience with the DMV by addressing wait times, staffing challenges, and customer satisfaction. Governor Stein's 2025-2027 budget proposal includes funding for 61 new Driver License Examiners and 24 new positions to staff new and expanded Driver License Offices. The House budget calls for this same expansion of DMV's staff. Governor Stein is committed to working with the General Assembly and the State Auditor's office to find and implement real solutions.
