# **Covid Update for Anson County**

Active cases in Anson County are climbing

According to the latest information posted by the Anson County Health Department on Wednesday, June 29 there were 6,939 total Covid-19 cases, with 170 of those cases active and 99 deaths. On June 22 there were 6,868 total cases, with 127 active and 99 deaths. On Friday, June 3 there were 6,714 cases, with 64 active and 99 deaths. The active cases continue climbing.

## **NC Turnpike Authority Encourages Safe Driving Habits During this Busy Travel Season**

As holiday travel picks up, the North Carolina Turnpike Authority (NCTA) is highlighting the safety benefits on the Triangle Expressway and Monroe Expressway while reminding drivers to practice safe driving habits.

"Delivering safe travel options for our drivers is the reason we get up in the morning," said Dennis Jernigan, Interim Chief Engineer of the NC Turnpike Authority. "We are asking all North Carolinians to drive with safety in mind as we work together to make North Carolina roads among the safest in the country.'

NCTA has designed its roadways and operations with safety as a top priority. These designs and modifications on both Triangle Expressway and Monroe Expressway include: Wide shoulders to provide drivers with ample room to pull their vehicles off the road if an emergency occurs

 Clear mile marker signage every 2/10 of a mile so drivers can more accurately report their location in an emergency · Highway lighting and interchange lighting along the Triangle Expressway to help increase visibility for drivers

 On-call maintenance crews remove debris from both roadways when necessary

• Wrong-Way Vehicle Detection Systems:

- Notifications to State Traffic Operations Center operators when a wrong-way vehicle is detected

- Flashing red lights on wrong way signs that illuminate

when a vehicle is detected · Enhancements to intersections associated with two offramps, modifications to traffic signals, and lane striping

 A partnership with State Highway Patrol to allow monitoring to ensure motorists are following traffic laws

and to respond quickly to roadway incidents

 Incident Management Assistance Patrol trucks that are equipped with specialized tools to assist stranded motorists

or first responders

#### **Change in Fire Extinguisher** Requirements for Recreational Boaters

Effective April 20, 2022, the U.S. Coast Guard (USCG) implemented a change in the fire extinguisher requirements for recreational vessels. If your vessel is currently required to carry a fire extinguisher, and the disposable (non-rechargeable) fire extinguisher has a date of manufacture stamped on the bottle, it is considered expired and must be removed from service if it is older than 12 years.

All recreational vessels of model year 2018 and newer meeting the current requirement to carry fire extinguishers must carry 5-B or 20-B rated fire extinguishers that are date stamped. Vessels older than model year 2018 may carry either 5-B or 20-B rated fire extinguishers that are less than 12-years-old or B-I or B-II rated fire extinguishers that are in good and serviceable condition. Once they are no longer in good and serviceable condition, they must be

replaced with a 5-B or 20-B date stamped fire extinguisher. Good and serviceable conditions means all the following are true:

- Pressure gauge reading or indicator is in the operable range or position. Lock pin is firmly in place.
- Discharge nozzle is clean and free of obstruction.
- Extinguisher does not show visible signs of significant
- corrosion or damage. The fire extinguisher type may be found on the label on

the bottle that will state "Marine Type – USCG Approved." If your boat is currently required to carry a fire

extinguisher, it is still required to do so under the new regulation. There is no change to the quantity of fire extinguishers required.



#### **Invasive Plants and Pests are Spreading** Faster, and They're Getting a Lot of Help

Now that the months have turned to summer, folks are spending more time outdoors. Whether that makes you an outdoor enthusiast, or simply puts you in the yard, in front of a grill or by the pool, you may notice new tree damage and unfamiliar insects. While many people associate tree damage with weather events, invasive species can crawl their way onto the scene quicker than one might expect. In fact, they don't have to crawl very far because they're getting plenty of help from outdoor recreationists.

Insects and diseases claim more timber each year than any other forest menace. Invasive forest pests including insects, diseases, plants and animals can have a dramatic effect on forest resources in North Carolina. These pests can, and have, hitchhiked their way to our state by way of wood packaging material and infested nursery plants. However, the primary cause for the spread of invasive pests continues to be human activity.

Fortunately, the process to help slow the spread of invasive species is a simple one. Think of it as washing your hands to prevent spreading germs. These non-native species can attach themselves to a variety of things such as RVs, camping tents, bicycle tires, boats, jet skis, clothes, boots or shoes and even pets. As people wrap up their outdoor activity and move on to a different area, if gear isn't thoroughly washed or wiped off, there's a good chance these uninvited guests are well on their way to finding a new home. Having the awareness to clean any and all gear and equipment used during outdoor activities continues to be the best defense against spreading invasive species.
