Second Body Identified in F&M McLendon Funeral Home Case

In a press release from Chief Thedis Spencer of the Wadesboro Police Department: On November 22, 2010 officers of the Wadesboro Police Department were contacted by the Anson County Sheriff's Office to assist in a foreclosure lock out at F&M McLendon Funeral Home. Officers were there serving strictly a peacekeeping role.

During this lockout, the Anson County Sheriff's Office found three bodies in the funeral home. The Wadesboro Police Department assisted the Anson County Sheriff's Office in identifying and removing these bodies. Sheriff Tommy Allen arranged with Leavitt Funeral Home to have the bodies transported there for storage until the families could make other arrangements. During this time it was found that the bodies were several months old.

Detectives with the Wadesboro Police Department investigated who these individuals were and why they remained at F&M McLendon Funeral Home. This investigation revealed that there was not a crime resulting from the bodies remaining at the funeral home and that there was not a crime with respect to the financial aspect of the funeral services either. Detectives with the Wadesboro Police Department, determined that the appropriate action was to turn this case over to the North Carolina Board of Funeral Directors. Wadesboro Police Department, as a courtesy, contacted all of the next of kin for the three bodies and helped them with the final arrangements of the bodies.

In the months and years following the initial foreclosure, the Wadesboro Police Department worked in conjunction with the North Carolina Board of Funeral Directors Investigator Carolyn Connors on several reports of misconduct at F&M McLendon Funeral Home. During the time that the North Carolina Board of Funeral Directors was investigating this case Funeral Director Mary McLendon-Brown made arrangements with the bank and was allowed to return to her building and continue operating. It was during this time that Marshall Ray Allen passed away and his body was turned over to Mary McLendon-Brown and F&M McLendon Funeral Home.

The North Carolina Board of Funeral Directors decided to revoke Mary McLendon-Brown's license and close F&M McLendon Funeral Home and then did so. This closure was a civil matter and therefore not within the jurisdiction of the Wadesboro Police Department. If officers were asked to accompany the North Carolina Board of Funeral Directors in closing F&M McLendon Funeral Home it would only be in a peacekeeping role, therefore officers were not legally justified to search F&M McLendon Funeral Home. At no point prior to the sentencing portion of the trial, State of North Carolina vs. Mary McLendon-Brown, did any officer of the Wadesboro Police Department have independent reasonable suspicion to believe that the body of Marshall Ray Allen was inside the building formally operated as F&M McLendon Funeral Home, and therefore no search warrant could be obtained.

On June 4, 2014, Officers with the Wadesboro Police Department located two bodies in the building formally operated as F&M McLendon Funeral Home. One body was quickly identified as that of Marshall Lee Allen. The other body remained unidentified until July 2. Working closely with the Mecklenburg County Medical Examiner's Office, detectives were able to positively identify the body as that of Henry Thomas Garris who died on November 23, 2011.

Chief Thedis Spencer said, "This investigation is still ongoing and no determination has been made regarding any charges that may or may not be brought against Mary McLendon-Brown."


Joel Hornback & Henry Martin Mark Site of Mt. Vernon School
