# **Lawrence Gatewood Announces Plans** to Step Down as County Manager at End of the Year



In a letter written to Anson County employees, County Manager Lawrence Gatewood announced that he is leaving his job at the end of the year.

In the letter Gatewood stated, "Last night (Monday, July 8) I informed the Board of Commissioners that I will step down as County Manager, effective December 31, 2013. I believe that with the Fiscal Year 2013-14 Budget completed and the new Emergency Services Center on track to be completed in December, now is the appropriate time for me to shift to some new challenges.

Gatewood's stated that he will be revising his schedule for the coming months to focus on a few kev priorities:

- 1) Successful completion of the construction of the Emergency Services Center
- Successful completion of the sale of county owned surplus timber and land 3) Helping the Board fill key vacancies, e.g. Library Program Assistant, Finance Officer,
- 4) Timely delivery of county water line from Highway 74 to the residents of Boylin Road
- 5) Finalize the purchase of 41.06 acres for the AGRI-CIVIC Center
- 6) Work closely with Waste Connections to deliver on the promised \$1 million goal in host
- 7) Continue to support the new hospital project

8) Assisting the Anson/Carolina Thread Trail team to complete Phase-1 of the Thread Trail project. "I want to thank the Anson County Board of Commissioners for this opportunity to serve the 26.948 citizens of this fine county, and I want to thank all staff for your continued hard work and support," Gatewood concluded. "I have thoroughly enjoyed it, and will continue doing so until December 31. Thank you.

### **Wadesboro Police Catch Serial Thief in the Act (Again)**

On Saturday, June 15 at approximately 2 a.m. Wadesboro Police Department Officers arrested Roger Lee Hunt, from Rowland, NC for the second time in only five months. Hunt was attempting to steal several tractors and trailers from Martin Brothers Equipment when officers conducting routine business checks observed some equipment moved from its usual place on the property. During the officers' investigation they located Hunt hiding under a trailer in the parking lot of Martin Brothers. Hunt was arrested and transported to the Anson County Jail.

Hunt received the following charges: Larceny (Felony); Attempted Larceny (Felony); Possession of burglary tools (Felony); Possession of drug paraphernalia (Misdemeanor); Injury to personal property (Misdemeanor); and Possession of stolen property (Misdemeanor). His bond was set at \$27,900 with a court date of July 2.

Hunt was also charged with the breaking and entering and larceny of Pinkstons. This case was reported on December 24, 2012, where three lawn mowers, a utility trailer and other items were stolen having a value of over \$35,000. This arrest was made on June 19, when Hunt was already in jail for the Martin Brothers case. He was charged with Breaking and Entering, and Larceny. Hunt's bond was set at \$50,000 for those charges, with a court date of July 2. Hunt had been arrested on January 14 when Wadesboro Police Officers observed him stealing a trailer from Anson Machine Shop on Highway 74 West. He was convicted of

### Polkton Man Drowned July 4th

Mark Baucom, 50, of Polkton drowned while vacationing at Myrtle Beach during the July 4th Holiday. According to reports Baucom was swimming with a friend in the area of 14th Avenue South. His friend came out of the ocean and was unable to find Baucom. At about 7:30 p.m. North Myrtle Beach 911 dispatchers received a call from a man who reported that he saw a body floating face down in the ocean near 16th Avenue South. Minutes later an officer with Beach Patrol radioed dispatchers to report that the victim was out of the water and receiving CPR. EMS and fire rescue arrived and took Baucom to Grand Strand Regional Medical Center where he was pronounced dead at 8:10 p.m.

Five other people died during the July 4th holidays in the Horry County, SC and Brunswick County, NC area, and at least 100 people were rescued. Officials reported that the victims got caught up in unusually strong rip currents being experienced in that area.

# Illegal Night Club Busted Again in Wadesboro

Special agents with the North Carolina Department of Public Safety's Alcohol Law Enforcement section and officers from the Wadesboro Police Department arrested 10 people at an illegal night club in Wadesboro on June 30. Npressions night club, located at 317 East Caswell Street (Highway 74), had been busted before for operating without the required Alcoholic Beverage Control permits.

The club's owner, Jefferson "Rex" Rivers, 39, of Wadesboro, was charged with three counts of possession of alcohol for sale without an ABC permit, three counts of allowing the possession or consumption of spirituous liquor on premises not authorized and two counts of maintaining a business that was resorted to by persons using marijuana in violation of the N.C. Controlled Substances Act. Npressions' bartender Bernea Ennea Ford, 35, of Wadesboro, was charged with two counts of selling alcohol without ABC permits.

Two people were arrested on warrants, and six others were cited and released on alcohol,

gun or drug charges.

ALE special agents seized 268 liters of malt beverage, spirituous liquor and unfortified wine along with three grams of marijuana, a gun, \$225 in cash, several television sets and digital video and audio equipment. Officers with the Wadesboro Police Department, deputies from the Anson County Sheriff's

Office and a dog handler from Adult Correction assisted ALE special agents in delivering a search warrant to Npressions. Special agents from four ALE districts, Charlotte, Conover, Greensboro and Fayetteville, as well as ALE's Special Operations Group, took part in the lengthy investigation and subsequent arrests.

## **Tdap Vaccination Clinic Next Tuesday** The Anson County Health Department will hold a Tdap vaccination clinic on Tuesday, July

16, from 5 until 7 p.m. at the Health Department, located at 110 West Ashe Street in Wadesboro. The Tdap vaccine gives protection against Tetanus, Diphtheria and Pertussis (Whooping Cough). ACIP (Advisory Committee on Immunization Practices) recommends that adolescents should

preferably receive the Tdap vaccine at  $11 ext{-}12$  years of age (before entering  $6 ext{th}$  grade). They also recommend adults (e.g., grandparents, childcare providers, and health-care practitioners) who have or who anticipate having close contact with an infant less than 12 months of age and who previously have not received Tdap should receive a single dose of Tdap to protect against pertussis and to reduce the likelihood of transmission. For other adults aged 65 years and older, a single dose of Tdap vaccine may be given instead of Td vaccine in persons who have not previously received Tdap.

Tdap can be administered regardless of the interval since the last tetanus- or diphtheriatoxoid containing vaccine. After receipt of Tdap, persons should continue to receive Td for

routine booster immunization against tetanus and diphtheria. For more information contact the Health Department at 704-694-5188.
