Lanesboro Inmate Loses Lawsuit **Over Lack of Safety at Prison**

Lanesboro Correctional Institution inmate Stacey Wynn, who is serving a life sentence for murder, has lost his lawsuit against the prison. He had sued the prison for "maintaining a dangerous environment" stating that he did not feel safe and that the source of the problem is corruption with the prison workers.

In court Wynn stated that he was assaulted twice by another inmate in 2011, stabbed and left permanently disabled. He alleged that former Lanesboro Prison Administrator Lawrence Parsons knew inmates were at risk, but showed "deliberate indifference." Wynn further stated that the prison had insufficient security.

Some testimony raised questions about whether Parsons and another top manager named Jeffery Wall were serious about keeping contraband out of the prison.

Attorneys for the state argued that Wynn failed to take advantage of several chances to prevent the second attack, which left him with severe injuries. The attorneys said he could have told prison officers about the first attack, but didn't. He could have requested protective custody, but didn't do that either.

Wynn said he didn't report the first attack because he didn't want to be branded a prison "snitch." He said this was a label that can get inmates hurt.

Defense attorneys also asserted that the incident in which Wynn was injured could have been a planned fight. The state made an attempt to get the case thrown out, but the judge agreed to send it to the jury.

Lanesboro is changing over over to all women inmates, with most in medium custody. This comes after a long most history of violence at the facility, including recent stabbings
