Unemployment Rates Increase in 84 NC Counties in June

Unemployment rates rose in 84 of North Carolina's 100 counties in June, fell in 11 and were unchanged in five. When compared to the same month last year, unemployment rates declined in 91 counties, increased in six, and remained the same in three.

Anson County's unemployment rate in June was 12.5%, a significant increase over May's 11.7% rate. Statewide the unemployment rate for June was 9.9%, May's rate was 9.4%. Looking back at June 2011, the rate then for Anson County also was 12.6%.

Anson's total labor force in June was 11,116. Of that number 9,724 were employed and 1,392 were unemployed. In May the total labor force was 10,998, with 9,709 employed and 1,289 unemployed. Looking at the numbers, Anson actually employed more people in June than in May, but the labor force increased and that caused the higher unemployement percentage.

"Over-the-year numbers are showing a positive trend compared to the June numbers," said N.C. Department of Commerce Deputy Secretary Dale Carroll. "Since June of last year, rates are down in nearly all of North Carolina's 100 counties. Job announcements continue to be made across our state and we remain focused on getting people back to work. Working with employers statewide and providing assistance in our employment service offices is critical to finding opportunities for our customers."

North Carolina had 39 counties that were at or below the state's not seasonally adjusted unemployment rate of 9.9 percent. Unemployment rates increased in all 14 Metropolitan Statistical Areas.

Statewide the number of workers employed (not seasonally adjusted) increased in June by 12,294 to 4,237,552, while those unemployed rose 22,088 to 463,123. Since June 2011, the number of workers unemployed decreased 45,492, while those employed increased 69,075.

Currituck County had the state's lowest unemployment rate in June at 5.3 percent, and Scotland County had the highest unemployment rate at 17.6 percent.

It is important to note that employment estimates are subject to large seasonal patterns; therefore, it is advisable to focus on over-the-year changes in the not seasonally adjusted series.

Sheriff Warns of Flim-Flams

In a release from Sheriff Tommy Allen: The Anson County Sheriff's Office continues to warn citizens of fraud and flim-flam scams that are reported regularly to the Sheriff's Office. Generally, these are some form of mail, fax, telephone, e-mail or internet scams, notifying individuals they have won money from some contest, lottery or third world individual who is asking for help getting money back into the United States.

Sheriff Tommy Allen said that the old rule still applies, "If it sounds too good to be true, it almost always is. I have a stack of Award Notifications, Lottery Payment Processing Forms, Claim Center Notifications, USA Survey Network (and the list goes on and on), who have contacted local citizens on their "winnings" and ask the individuals to send them a 'processing fee, finders fee, or tax fee' for helping them with some contest that they've never entered. These letters will often be postmarked Canada or some third world country or even an island resort. Do NOT call any phone numbers listed on these letters. Sometimes that is the only thing they are trying to get you to do. You may be billed hundreds of dollars for that one "international" call."

The Sheriff said there are three things to always remember: 1) You will never win any lottery, contest or drawing that you have NEVER entered; 2) NO legitimate contest will ever ask you to send money back to them under any circumstances; 3) No legitimate person is going to contact you and promise to pay your bills and ask you to send them money in the process.

We recently have had several instances of the latter. Individuals developing a relationship correspondence with someone on Facebook or some similar social network. They ask the victim to send them money in return they promise to send a large amount of money soon. Or they send them a large check that they ask them to deposit and return a portion back to them. Of course the check will bounce a few days later, but it's too late because the victim has already sent the money by "wire" to the individual. One person recently lost \$10,000 to this scam; another \$1,400.

Anything remotely similar to what I've just described is 100% fraud and flim-flam. Remember, if it seems too good to be true...it is!!! Take time to check it out. Any legitimate business will welcome that and the crooks will not wait around.

Former men and women of the military who are not currently enrolled for VA health care benefits or who would like to file a claim will need to bring copies of their DD Form 214, Certificate of Release or Discharge from Active Duty, to attach to their applications for VA benefits. If you have lost your DD Form 214, you can request a copy from www.archives.gov/veterans/military-service-records/. VA personnel will assist in completing enrollment applications, claims, requesting DD Form 214s, and initiating MyHealtheVet online services. "I Remember Beautiful Windows and Exquisite Architectural Details"



Ansonians driving through uptown Wadesboro will notice the former Belk Building, now county offices, is undergoing a major facelift. It is quite surprising to see a beautiful facade emerging as the old white front panels are removed.

When I asked Anson County Manager Mr. Lawrence Gatewood if the original beauty of the Belk Building was known before the current restoration began, he said, "Mr. John Dunlap and former Belk Manager Mr. George Matthews both remembered beautiful windows and exquisite architectural details. These architectural details are becoming more and more apparent as panels are removed."

The panels, which covered the face of the building, were installed in 1954.

"We didn't go into this blindly. We decided to remove some of the panels and uncovered something beautiful. We hope to restore the building as closely to its original grandeur as possible," said Gatewood.
