## 2,719 Total Cases of COVID-19 in Anson County

#### Vaccines are available. Ansonians urged to get vaccinated.

The latest information posted by the Anson County Health Department was 2,719 total Covid-19 cases, with 42 active as of Monday, July 26. The last report in The Express was from July 26, with 2,685 total cases and 25 active. On July 23 the Health Department reported another death related to Covid, bringing the total in Anson County to 58.

The NC Department of Health and Human Services (NCDHHS) reported that statewide as of Monday, August 2 there were 2,190 new cases, with 13,670 deaths and 1,359 hospitalized. 61% of adults in NC were vaccinated with at least one dose, 58% were fully vaccinated.

Statewide, as of Monday, July 12 there were 562 new cases of COVID-19, with 13,499 deaths and 448 hospitalized. On June 7 there were 359 new cases of COVID-19, with 13,199 deaths and 546 hospitalized. May 3 there were 1,126 new cases of COVID-19, with 12,691 deaths and 1,007 hospitalized. April 5 there were 1,054 new cases of COVID-19, with 12,173 deaths and 907 hospitalized. March 1 there were 862,170 cases of COVID-19, 11,254 deaths and 1,219 hospitalized. February 1: 761,302 cases, 9,342 deaths and 2,781 hospitalized. January 4: 570,111 cases, 6,941 deaths and 3,192 hospitalized. December 7: 404,032 cases, 5,605 deaths and 2,373 hospitalized. November 2: 278.028 cases, 4,390 deaths and 1,146 hospitalized. October 5: 219,754 cases, 3,637 deaths and 971 hospitalized.

It was announced that due to changes in state requirements, Anson County Schools will not have a Virtual Academy for the 2021-2022 school year. Superintendent Howard McLean will re-evaluate the state process during the spring. There will be no virtual learning opportunities during this school year.

Also, the board approved for all school-based students and staff to wear mask indoors and outdoors for the 2021-2022 school year.
