## 2,798 Total Cases of **COVID-19 in Anson County**

Vaccines are available. Ansonians urged to get vaccinated.

The latest information posted by the Anson County Health Department was 2,798 total Covid-19 cases, with 96 active and 58 deaths as of Monday, August 9. Last Monday, August 2 there were 2,719 cases, with 42 active.

Health Director Fred Thompson, PhD gave this update on August 5. "Just a short note to alert you to the surge in the number of COVID-19 cases we are seeing in Anson County due to the Delta variant. We have had 58 new cases in the last week, including 15 today. To put that in perspective, in May and June we were averaging 0 to 2 cases daily. Almost all of these new cases are occurring in younger unvaccinated people.

According to the NC Department of Health and Human Services, over 92% of new cases of COVID-19 in NC are occurring in people who are not vaccinated. And, according to the Centers for Disease Control and Prevention (CDC), approximately 97% of hospitalizations and deaths are in people who were not vaccinated. become a pandemic of the unvaccinated.

From a Public Health perspective, the surge we are seeing due to the Delta variant is both frustrating and preventable. We have vaccines that are safe and effective in protecting people from getting COVID-19 and preventing both hospitalizations and deaths. In Anson County, only 35% of the county's population

is fully vaccinated. Everyone 12 and over is eligible to get vaccinated at no cost. The Health Department is vaccinating on Tuesdays with the Moderna vaccine for those 18 and over. No appointment is needed to get vaccinated at the Health Department. Just come on over on Tuesday and we will get you vaccinated. Also, our local CVS pharmacy offers the Pfizer vaccine by appointment for the 12 to 17 age group. Far and away the best tool we have to prevent the spread

of the COVID-19 virus, including the Delta variant, is vaccination. Please join me in encouraging everyone you know, 12 and over, who are not vaccinated, to get vaccinated to protect themselves, their family, and the Anson County community. Thank you.

The NC Department of Health and Human Services (NCDHHS) reported that statewide as of Monday, August there were 3863 new cases, with 13,759 deaths and 1,946 hospitalized. 62% of adults in NC were vaccinated with at least one dose, 58% were fully vaccinated. On Monday, August 2 there were 2,190 new cases, with 13,670 deaths and 1,359 hospitalized.

# Anson County Road Project Starts Next Week

Construction will start Monday to convert the U.S. 74/Camden Road intersection in ilesville to a reduced conflict intersection, or RCI. The \$821,000 contract was recently awarded to J.T. Russell & Sons Inc. out of Albemarle.

## Four out of five consumers are seeing premiums of less than \$10

After a historic seven-month run to offer additional enrollment opportunities for people impacted by COVID-19, this year's Affordable Care Act (ACA) Special Open Enrollment Period is coming to a close in just five days, ending at 11:59 p.m. this Sunday, August 15. As of June 30, more than 91,000 North Carolinians have taken advantage of this opportunity. Through the end of this Special Open Enrollment Period, NC Navigator Consortium Marketplace Navigators are providing free virtual and in-person one-on-one enrollment assistance to people seeking affordable, quality health coverage. Thanks to the American Rescue Plan Act, signed into law in March to provide

economic relief in response to the COVID pandemic, the subsidies are much larger for 2021, and are designed to reach a greater number of people. "Those folks who need it the most are now able to get the help they need," said Mark Van Arnam, director of the statewide NC Navigator Consortium. "Four out of five consumers are seeing premiums of less than \$10. North Carolinians who enrolled in a Marketplace health insurance plan on Health-

Care.gov before March can get even lower monthly premiums by returning to Health-Care.gov and updating their application to obtain these new discounts. Current enrollees in North Carolina who have updated their application lowered their monthly health insurance costs by 43%. "Not to mention," Van Arnam added, "that anyone who has been approved for unemployment compensation can get a plan to cover the rest of 2021 that costs nothing

- zero dollars," he said. However, Van Arnam cautioned, people should take action right now, since these discounts may not be available for next year. "Get a plan now, Van Arnam urged, "and get the health care attention you may have been putting off, while it's extraordinarily affordable.' North Carolinians have options when scheduling free Navigator enrollment help to buy

Health Insurance Marketplace coverage: virtual assistance available by phone or Zoom, or in-person appointments where available. Visit www.NCNavigator.net or call (855) 733-3711 to book your free appointment today.

The Open Enrollment Period to buy 2022 insurance is also just around the corner, scheduled to begin November 1. The NC Navigator Consortium is a group of six health care, social service and legal

aid organizations that helps North Carolina consumers enroll in affordable, comprehensive health insurance plans on HealthCare.gov, the Health Insurance Marketplace established by the Affordable Care Act. ### Radio, Television and Cell Phone National Emergency Alert Test is Scheduled for Today, August 11 BEEEEEEEP! "This is a test of the Emergency Alert System."

Many of us know that familiar test from radio and TV, and on August 11, many people

in the United States will receive it on their cell phones. The Federal Emergency Management Agency, in coordination with the Federal Communications Commission (FCC), will conduct a nationwide test of the Emergency Alert System (EAS) and Wireless Emergency Alert (WEA) on August 11, between 2:20 and 2:50 p.m. EDT. This will be the second nationwide WEA test, but is the first nationwide WEA test on a

consumer opt-in basis. It will be received by consumers who have emergency alerts activated on their cell phones. The test message will display in either English or in Spanish, depending on the language settings of the phone. The Emergency Alert System portion of the test will be sent to radios and televisions

This will be the sixth nationwide EAS test. The WEA test message will cause an audible alert tone on phones and the

message will read: "THIS IS A TEST of the National Wireless Emergency Alert System No action is needed." WEA is a voluntary program with most major cellular providers participating, but some

smaller carriers do not participate. The message will not be received is a phone is turned off, out of range of a cellular tower, has emergency alerts turned off in its settings, or it it is an older cellular phone that is not WEA capable.

There is no need to take any action upon receiving the test message. Do not panic or call 911 to ask questions when you receive the test message.

Organizations that will be holding meetings or large gatherings on Wednesday, August 11 during the 2 p.m. EDT hour may want to inform their audiences about the test so people are not surprised by the alert tone from cell phones.
