## Marshville Man Arrested in Connection with **1988 Murder of John Griffin in Anson County**



Anson County Sheriff Tommy Allen announced on Tuesday, August 12 that Marshville resident Eddie Clyde Helms, 61, had been arrested by Union County Sheriff Eddie Cathey for two murders, one of which involved Ansonian John Terow Griffin III that occurred in 1988. The other murder victim was Charles Ronald Godwin on August 30, 2012 24 years after Griffin's murder.

Griffin was murdered on November 10, 1988. He was shot in the back while installing a TV antenna on his roof. This occurred in Peachland. Godwin was also shot in the back.

Clvde Helms Helms was taken into custody by members of the Union Sheriff's Special Response Team at about 6:30 a.m. at his home, located at 6912 Fountain Hill Church Road. He operated a business called Prograde Professional Grading and Landscaping.

Helms' residence was being searched with evidence being collected as of press time Tuesday. The investigation of Godwin's murder led detectives to the Griffin case as evidence developed. A parallel investigation was commenced into the 1988 murder also. Evidence gathered built a case that resulted in Helm's arrest on Tuesday.

In both cases there are similarities. The victims were shot in the back by a shotgun. Evidence shows that neither victim saw their attacker because he snuck up on them in the dark. No information has been provided as to a motive for the murders. Sheriff Cathey did say that he believed, "anger and jealousy played a key role."

Helms has also been charged for allegedly stalking Godwin and a female acquaintance. Helms has been charged with First Degree Murder, Shooting into an Occupied Dwelling, and two counts of Stalking in the Union County case. He was also served a warrant for First Degree Murder in the Griffin death. He is being held in the Union County Jail without bond. He has a pending a court date of September 22 for the Anson County charge, and September 30 for Union County.

The Union County Sheriff's Office was joined in the investigation by the State Bureau of Investigation and the Anson County Sheriff's Office.

Commissioner Vancine Sturdivant was accessible to acknowledge the community during the Health Fair. Ms. Sturdivant encouraged fun, fellowship, and announced the winners of door prizes. Landric Reid reviewed child car seat safety and its proper use to ensure protection while driving. The Wadesboro Police Department distributed brochures supporting gun safety and offered child gun safety locks to the community. The Lilesville Fire Department explained fire safety in the home and obtained names of individuals who needed smoke detectors - delivering smoke detectors to homes free of charge.

Organizers gave a special thank you to Dr. Lincoln, Dr. Lisa Bracey, and Mr. Samuel Cash who answered questions, and delivered a wealth of knowledge to the community on various diseases, signs, symptoms and instructions for general health in maintaining the theme of the Health Fair "Complete Health Begins with You.

#### The Fracking Fight Heats Up in Anson County

Pee Dee W.A.L.L invites all concerned Anson County residents to an urgent meeting on fracking Tuesday, August 19 at 6:30 p.m. at the Hampton Library in Wadesboro. Pee Dee W.A.L.L. Proposes to adopt a chemical disclosure resolution that can potentially stop fracking from coming into Anson County.

"If you have never been involved in environmental issues before, this is one issue worth fighting. For the past year and a half Pee Dee W.A.L.L., a non-profit group of concerned citizens, has been working to protect Anson County's environment and natural resources from fracking. Fracking, also known as hydraulic fracturing, is a very controversial method which the gas and oil industry uses to extract natural gas out of shale rock. In order to frack one well, up to 10 million gallons of fresh water and sand tainted with a cocktail of over 500 hazardous chemicals is pumped into the ground. This tainted water can never be used again. It is hazardous. Cary Rodgers, pastor of Pathway to Peace Ministries and community organizer with Blue Ridge Environmental Defense League, said, "From my detailed research there is nothing good about fracking for Anson County. Reports from other states that have allowed fracking reveal that both well and municipal water systems are at high risks of contamination.

Rodgers continued, "Water is one of our most valuable resources, especially for our farmers. Once our water is contaminated with fracking's toxic brew it will never be the same again. Also there have been reports of increased air pollution, agricultural damage. sick livestock and an increased burden on rural community infrastructure."

Last spring 2013, Pee Dee W.A.L.L along with other Anson County citizens were able to strategize and energize a grass roots effort to convince Anson county commissioners to place a five year fracking moratorium in Anson County. Pee Dee W.A.L.L was victorious, but realized that was only a temporary "fence." Earlier this summer the NC state legislature made fracking legal statewide. Currently provisions in this law can legally challenge Anson County's five year fracking moratorium and try make it null and void. It is projected that the state will be issuing permits for oil and gas companies to drill as early as next spring 2015.

Lee said that, "Despite the legalization of fracking in the state, we can still put together more legal strategies to protect our water, air, lives, and assets in Anson County. Did you know that the current NC fracking rules now allow a fracking well to only be 650 feet from your house? Do you want that?"

Rodgers concluded, "We are still at great risk and the fight is heating up. We need each other to keep up the fight. This is not the time to sit and relax. Do you want a loud industrial, air and water polluting fracking well next to your country home or neighborhood? I did not move here for that!"
