Anson County 2012 property tax bills were mailed to taxpayers on Tuesday, August 7th. Property tax bills are due September 1st, and considered delinquent January 7, 2013.

Tax bills can be paid in two ways:

1) Taxpayers can mail their payments to Anson County Government Center, 101 South Greene Street, Suite 115, Wadesboro, NC 28170; or 2) Pay in person at the Anson County Government Center (101 South Greene Street in Wadesboro) between the hours of 8:30 a.m. and 5 p.m. weekdays. Payments postmarked after January 7, 2013, will be considered

delinguent and assessed 2% interest for the first month, and 3/4% for all months thereafter until paid. Delinquent taxes will be advertised and a \$10 per tax bill assessment will be applied. Questions regarding property listings, real estate values or tax bills should
