#### **One Stop-Early Voting for 9th Congressional District Contest Begins Today**

Early voting began today, Wednesday, August 21, for the upcoming September 10 General Election to fill the vacancy in North Carolina's 9th congressional district in the United States House of Representatives for the remainder of the 116th United States Congress. Voters will chose between Dan McCready, the Democrat Party candidate, Republican Dan Bishop, Libertarian Jeff Scott and Green Party member Allen Smith.

The seat has been vacant since the opening of the 116th Congress, following the refusal of the North Carolina State Board of Elections to certify the results of the November 2018 election in the district due to allegations of electoral fraud. One Stop Early Voting takes place at the Anson County Board of Elections Office, which is located at 402 Morven Road in Wadesboro. The hours are Monday through Friday, 7 a.m. to 7 p.m. Early Voting runs

through Friday, September 6.

If you don't vote during Early Voting you will need to vote at your regular polling precinct on Election Day, Tuesday, September 10, from 6:30 a.m. to 7:30 p.m. There will be no voting at the Board of Elections Office on Election Day. **Registration to Vote** for this election ended on August 18. If you are already registered to vote in Anson County, and your name or address has not changed, you did not need to register to vote again. Voters who did not register by the August 18 deadline may register and vote during One Stop Early Voting only, and will be required to show documentation of their identity and residence in the form of current and valid photo identification, or a copy of one of the following documents that show the name and address of the voter: a current utility bill, bank statement, government check, paycheck or other government document. Absentee By Mail Voting is available upon request from the voter, a near relative or legal guardian\*. New state law requires that all requests must be made on the official Absentee Ballot Request Form, which is available online at www.co.anson.nc.us/202/Board-of-Elections. Or application may be made in person at the Anson County Board of Elections Office, or in writing to the Anson County Board of Elections at PO Box 768, Wadesboro, NC 28170. The deadline to apply for an Absentee By Mail Ballot is 5 p.m. on Tuesday, September 3. (\*Near relative is defined as: spouse, brother, sister, parent, grandparent, child, grandchild, mother-in-law, father-in-law,

### Free Groceries Available to **Eligible Families this Saturday**

A new shipment of USDA foods will be distributed on Saturday, August 24, from 1 p.m. until 3 p.m., or as long as supplies last, at Burnsville Recreation & Learning Center (BRLC). Please note that neighbors will only be served once monthly with these items as long as they last.

The items are distributed on a first come, first served basis for eligible Anson County citizens.

All participants who plan to pick up food are asked to

bring someone to help them if they need help, as BRLC will no longer be able to provide this support. The North Carolina Department of Agriculture and

Consumer Services Food Distribution Division provide these food items through the Second Harvest Food Bank of Metrolina in Charlotte.

The US federal income guidelines will be a determining factor for individual's eligibility. The food items will only be available to Ansonians. Individuals who have not registered or received food before from the BRLC Emergency food Pantry must have financial documentation as proof of income to be served. Those families who receive food stamp assistance will automatically qualify. Parents are asked not to bring children due to limited seating space. Neighbors are asked to please park in parking lot behind center.

The USDA prohibits discrimination against its customers, employees and applicants on the bases of race, color, national origin, age, disability, sex gender identity, religion, reprisal, and where applicable, political belief, marital status, familial or parental status, sexual orientation, or if all or part of an individual's income is derived from any public assistance program, or protected genetic information

### Celebrating Smokey Bear on His 75th Birthday

North Carolina Insurance Commissioner and State Fire Marshal Mike Causey wishes a very happy birthday to Smokey Bear, the mascot of wildfire prevention in the United States, who turned 75 on Friday, August 9. The Smokey Bear Wildfire Prevention campaign was created in 1944 and is the longest-running public service advertising campaign in U.S. history. "Smokey Bear is one of the world's most recognizable

and lovable characters," said Commissioner Causey. 'He's been educating American children and families for generations about their role in preventing wildfires and Smokey's message is just as relevant and urgent today as it was in 1944." Smokey Bear was created during World War II.

With experienced firefighters deployed in the war, communities were faced with the difficult task of dealing with wildfires. Federal officials feared national forests could become targets. On August 9, 1944, the U.S. Forest Service created Smokey Bear as the national symbol for a fire prevention campaign.

is located at 13349 Highway 742 North in Burnsville, Smokey's face appeared on posters, billboards, and postage stamps with his famous slogan: "Only you can prevent forest fires. In 1950, firefighters in New Mexico's Capitan Mountains found a bear cub with burn

> injuries to his paws and hind legs after a fire. The cub was named Smokey Bear in honor of New York Assistant Fire Chief "Smokey" Joe Martin. The bear died in 1976 and was buried in what is now called the Smokey Bear Historical Park in Capitan, not far from where he was found. In 2001, Smokey Bear's slogan was updated to: "Only you can prevent wildfires." Although Smokey Bear has already accomplished so much in his 75-year history, his work

is far from over as wildfire prevention remains crucial, including here in North Carolina. In 2018, there were 3,625 wildfires in North Carolina resulting in more than

18,000 acres burned across the state, according to the National Interagency Fire Center. State Fire Marshal Mike Causey and the Office of State Fire Marshal want you to celebrate Smokey Bear's birthday by remembering his important catchphrase: Only you can prevent wildfires.
