Another COVID-19 Death in Anson County Over the Weekend

Vaccines are available. Ansonians urged to get vaccinated.

The latest information posted by the Anson County Health Department posted on Monday, August 23 showed 2,968 total Covid-19 cases, with 156 active. Over the weekend there was another death from Covid-19, bringing the total deaths to 61. Last Monday, August 16 there were 2,859 total Covid-19 cases, with 95 active and 60 deaths.

Vaccines are available, including walk-in clinics. They are free, and all you have to do is call the Health Department at 704-694-5188 for more information.

The NC Department of Health and Human Services (NCDHHS) reported that statewide as of Monday, August 23 there were 5,184 new cases, with 14,120 deaths and 3,197 hospitalized. 64% of adults in NC were vaccinated with at least one dose, 59% were fully vaccinated.

Statewide, as of Monday, August 2 there were 2,190 new cases, with 13,670 deaths and 1,359 hospitalized. July 12 there were 562 new cases of COVID-19, with 13,499 deaths and 448 hospitalized. On June 7 there were 359 new cases of COVID-19, with 13,199 deaths and 546 hospitalized. May 3 there were 1,126 new cases of COVID-19, with 12,691 deaths and 1,007 hospitalized. April 5 there were 1.054 new cases of COVID-19, with 12,173 deaths and 907 hospitalized. March 1 there were 862,170 cases of COVID-19, 11,254 deaths and 1,219 hospitalized. February 1: 761,302 cases, 9,342 deaths and 2,781 hospitalized. January 4: 570,111 cases, 6,941 deaths and 3,192 hospitalized. December 7: 404,032 cases, 5,605 deaths and 2,373 hospitalized. November 2: 278.028 cases, 4,390 deaths and 1,146 hospitalized. October 5: 219,754 cases, 3,637 deaths and 971

Employment Figures Released The state's seasonally adjusted July unemployment rate

was 4.4 percent, decreasing 0.2 of a percentage point from June's revised rate. The national rate decreased 0.5 of a percentage point to 5.4 percent. North Carolina's July 2021 unemployment rate

decreased 4.4 percentage points from a year ago. The

number of people employed increased 8,361 over the

month to 4,777,400 and increased 278,125 over the year. The number of people unemployed decreased 9,579 over the month to 222,315 and decreased 210,978 over the year. Seasonally adjusted Total Nonfarm employment, as gathered through the monthly establishment survey, increased 75,600 to 4,580,800 in July. Major industries experiencing increases were Government, 53,800; Professional & Business Services, 10,700; Construction, 4,300; Leisure & Hospitality Services, 3,800; Manufacturing, 3,100; Financial Activities, 600; and Other Services, 600. Major industries experiencing decreases were Education & Health Services, 900; and Information, 400. Mining & Logging and Trade, Transportation & Utilities employment remained unchanged.

Since July 2020, Total Nonfarm jobs increased 270,200 with the Total Private sector increasing by 215,400 and Government increasing by 54,800. Major industries experiencing increases were Leisure & Hospitality Services, 70,200; Government, 54,800; Professional & Business Services, 46,100; Trade, Transportation & Utilities, 34,700; Manufacturing, 23,800; Construction, 16,100; Education & Health Services, 8,100; Information, 5,800; Other Services, 5,800; Financial Activities, 4,600; and Mining & Logging, 200.

Swifts, over the past century, have been extremely adaptable - learning to roost in urban chimneys as large hollow trees and caves, their natural roosting sites, disappeared. But populations are decreasing steeply 53 percent between 1966 and 2007 in the United States - as chimneys are capped or removed, leaving fewer places for swifts to nest and raise their chicks. Chimney Swifts are now listed as "near threatened." Now, we are asking for your help for another bird in

need that can benefit greatly from the power of Audubon North Carolina's Bird-Friendly Communities, the Chimney Swift - our 2016 Bird of the Year.

Because the swift has become a truly urban bird, they frequently co-exist with humans. But with changes in our human behaviors and landscapes their ability to adapt even more is questionable. This is where you come in. There are so many ways to help this unique bird thrive in your own community. Here are four things you can do to support Chimney Swifts:

1. Keep Your Chimney Open – The practice of capping older chimneys makes

them inaccessible to swifts. One solution is to hire a chimney sweep to cap the chimney

in November and open it up again before Chimney Swifts arrive in the spring. Or simply keep your chimney open. Newer chimneys tend to have metal liners that are too slick for the swifts to perch on, so older chimneys with brick linings are really important. Share your commitment to keep your chimney friendly for swifts here. 2. Become a Community Scientist - Report nesting and roosting Chimney Swift sightings at surveymonkey.com/r/WTQ9H6V or at eBird.org. The

more we know about Chimney Swift roost sites, the better we can protect them. Chimney Swifts are in North Carolina from late March through October. The rest of the year they are either migrating or on wintering grounds.

If you're already an eBird user, please enter your observations following these recommendations from eBird staff: Include Chimney Swift Roost or Chimney Swift Nest in the Location Name.
 Choose "Stationary Count".

 Include only Chimney Swifts on your checklist and select "No" to indicate you are not reporting all the species you were able to identify. • Resist the temptation to make the chimney or tower a hotspot. 3. Construct A Chimney Swift Tower - Provide more nesting habitat to your neighborhood swifts. We recommend

this book on building swift towers by Chimney Swift experts Paul and Georgean Kyle. There are also great videos available online to help you get started. Swift towers make excellent Eagle Scout projects. Schoolyards, church grounds, parks and other open areas make good sites. Register Chimney Swift towers here. 4. Save Roost Towers - Schools and industrial buildings are replacing heating and cooling systems at a rapid rate

in North Carolina, causing the loss of suitable roost towers. Be proactive and write letters and arrange to meet with school administrators, facilities managers, and others who influence decisions on chimneys before plans are made to tear the chimney down. Friday Airplane Crash Near Airport Kills Both Onboard

According to a release from Town Wadesboro, on Friday, August 20 about $10{:}15 \ a.m.$ the Wadesboro Fire Department, along with Anson County

aircraft crash north of the Anson County Airport. Upon arrival crews located the aircraft in a wooded area already fully engulfed in flames. After extinguishing the fire, it was determined that there were no survivors. As of press time the men were not identified. It was reported that the plane, identified as a newly purchased Piper PA-24 Comanche

that had not flown in 15 years, had landed at the Anson County Airport after leaving a nearby airport, with two men aboard. They fueled up using the self serve pump. Vitnesses said that after fueling the engine was difficult to start up, and did not be running right, backfiring and popping. Upon takeoff, as the plane passed over the end of the runway, a witness said they heard two very loud pops, almost like shotgun blasts. The plane climbed a few hundred feet, then crashed into the woods not far from the runway, just off Little Duncan Road, near Highway 52. Aviation fuel service was stopped temporarily while the fuel at the airport underwent a

quality test. It passed the check and the airport is dispensing fuel again. The Federal Aviation Administration (FAA) and National Transportation Safety Board

(NTSB) are investigating the crash.

FDA Approves Pfizer Vaccine for Those 16 and Older The Food and Drug Administration has approved the Pfizer-BioNTech COVID-19 vac-

cine, which Pfizer is calling Comirnaty, for the prevention of COVID-19 disease in individuals 16 years of age and older. "Vaccines are our most important tool in the fight against COVID-19," said NC Department of Health and Human Services Secretary Mandy K. Cohen, M.D. "All authorized

vaccines have met rigorous testing and scientific standards. Millions of North Carolinians have been safely vaccinated, but for some people full FDA approval provides additional confidence. If you are not vaccinated, we urge you: please don't wait to vaccinate." The Pfizer vaccine will continue to be available under emergency use authorization for teens 12-15. FDA approval for this age group will require additional time as the vaccine

was not authorized for younger teens until May 2021, six months after it was granted EUA for people 16 and older. All available vaccines in the United States have been under an EUA. Rigorous clinical trials among thousands of people have proven that vaccines are safe and effective. More than 170 million Americans have been safely vaccinated against COVID-19. Vaccines are widely available in North Carolina. Through Aug. 31, anyone 18 and older who gets their first dose of a COVID-19 vaccine at a participating location will

receive a \$100 Summer Card* in the form of a Prepaid Mastercard while supplies last. Last week the Centers for Disease Control and Prevention shared new data showing vaccines continue to be remarkably effective in reducing risk of severe disease, hospital-

ization and death, even against the widely circulating Delta variant. There is urgency to get vaccinated now. North Carolina is experiencing the fastest acceleration in cases since the pandemic started. Earlier this month, the state had the largest single-day jump in ICU admissions since the beginning of the pandemic. Anyone who has symptoms of or has been exposed to COVID-19 should get tested as soon as possible. To find a testing site in your community, go to www.ncdhhs.gov/GetTested.

People should seek medical attention immediately for serious symptoms such as trouble breathing, persistent pain or pressure in the chest, new confusion or inability to arouse, or bluish lips or face. While vaccines are the best protection against serious illness, hospitalization and death

monoclonal antibody therapy can reduce the severity of COVID-19 symptoms and decrease the likelihood of hospitalization, especially in high-risk patients. If you test positive for COVID-19, monoclonal antibody therapy must be administered within 10 days of your first COVID-19 symptoms, so it is crucial to get tested early.
