The Anson County Writers' Club (ACWC) is pleased to announce its annual contests for prose and poetry. The contests are divided into adult, youth, and children's categories. • The adult contests are open to anyone residing in, having resided in, attending school in, or working in Anson County; or members of the ACWC. There is a \$1 entry fee that is waived for students at any institution of higher learning. • There is no entry fee for students in grades 3-12. Rules and entry forms will be provided to all Anson County schools. Home-schooled students are also invited to enter. A complete copy of the rules and an entry form that must accompany each entry are available at the Hampton B. Allen Library or by writing to: ACWC 2019 Contests, P.O. Box 363, Wadesboro, N.C., 28170 (enclose a self-addressed, stamped envelope). Rules and entry forms may also be printed from the website at www.ansoncountywritersclub.org. The deadline for the 2019 contests is 5:30 p.m. on Monday, December 9. The ACWC will award over \$400 in prize money to the winners of the annual writing contests. First, second and third place winners in the adult prose and adult poetry categories will receive \$50, \$30 and \$20, respectively. Youth winners (grades 9-12) will receive \$20, \$15 and \$10, respectively. Grades 3-5 and Grades 6-8 will compete separately in the children's division. Prizes are \$15, \$10 and \$5, respectively, for prose and poetry winners in both categories. All winners will receive a certificate suitable for framing and will be honored at a reception for friends and family on Sunday, February 23, 2020. Winning entries of the contests will be published in an anthology, Anson Pathways XI, which will be released in 2022. Anson Pathways has been published every three years since 1991. The contest committee urges writers to study the contest rules carefully. In past years, some excellent entries that might have won were disqualified because the writers did not follow instructions. Remembering.....

Twin Valley Country Club

This one goes back a few years - many who golf at Twin Valley Country Club were not yet born when this club began. The original building was built just after the Depression years...in the mid 1930's, by the WPA. Many additions to the facilities have been made since. I was talking with John Dunlap - he remembers as a boy, his first caddying job was for Rev. Paul Hardin, the First Methodist minister from 1935 to 1939. His pay was 50¢ for one round, and a "whole dollar" for two rounds. Other experiences as "Twin Valley Golfers" were Bill Bias and John Livingston - another story! I remember Dr. Frank "Skinny" Fetzer wanted me to letter a bench at the club in 1937 or 1938. After getting a ride from Ansonville one Saturday morning, I went to get instructions from him at Fox & Lyon Drug Store - he finally got to work about 9 or 10 a.m. (after I had walked from the store to his house on Wanoka Circle and was told to go back to the store and wait!). He carried me out to the club house where I, after a considerable amount of time, finished lettering the bench "Fox & Lyon Drug Store." I did get "slightly more than 75¢" for the above sign that I did on January 7, 1975. It is all steel construction - post, frame and ornamentation, with a hand-lettered baked aluminum sign panel.
