### Thompson's Super Market

Bet you don't remember this one! Bill Thompson was a young man here in town and worked at (Carlyle) Braswell's Grocery Store on Rutherford Street for some time. Bill later opened a grocery store on Salisbury Street at the location that was formerly Snyder's Grocery. All of this as I remember happened in the 1950's.

In 1958, he built a new store on Highway 74 West next door to what is now the Hub Restaurant. I did the big sign at the street entrance January 14, 1958.

In those days I painted "weekend" specials for the windows - the above specials were for October 15, 1959 and bacon was 39¢ a pound, large Tide was 19¢, a quart of Wesson oil - only 39¢ - there also was a jackpot drawing of \$12.50

In later years, Bill sold out and moved to Winston-Salem with wife Jean and baby daughter Kay. Kay is now married - she, her husband and their two children live in Huntersville. Bill and Jean are doing ok - still working!
