People Fest Cancelled for this Year

At their regular monthly meeting on Monday evening, September 12, the Wadesboro Town Council made the decision to cancel this year's People Fest celebration, which was scheduled for Saturday, October 22. The cancellation was necessary because there is not enough time to accomplish all of the many things that must be done in preparation due to the passing of an integral member of the People Fest team, Eddie Pope. There were also some scheduling conflicts.

The Uptown Wadesboro Fall Festival, which has traditionally been held at the end of October, had been scheduled to coincide with People Fest for this year. With People Fest's cancellation, Uptown Wadesboro, Inc. (UWI) is considering rescheduling the Fall Festival to the last Saturday in October, the 29th. That would allow the festival to be closer to Halloween, which has been an important component of the activities in the past. Once a decision has been made The Express will report that to the community.

Wadesboro Considering a New Fire Station, Announces Public Hearing

At their regular monthly meeting on Monday, September 12 the Wadesboro Town Council issued an announcement for a public hearing to be held on Tuesday, September 27 to offer details for a proposed new fire station building. This hearing will also be a forum for the public to be heard on the subject. The release is below:

The Town Council of the Town of Wadesboro, North Carolina (the "Town") has determined to consider whether to enter into an installment financing agreement (the "Agreement") pursuant to Section 160A-20 of the General Statutes of North Carolina obligating the Town to make installment financing payments thereunder in a principal amount not to exceed \$1.100.000 for the purpose of providing funds, together with other available funds, to pay the costs of acquiring, site prepping, constructing and equipping a public safety station to house fire department functions to be located on E. Morgan Street near the intersection of E. Morgan Street and Morven Road (the "Project"). To secure its obligations under the Agreement, the Town will grant a lien on the site of the Project, together with any improve ments or fixtures located or to be located thereon.

Section 160A-20(g) of the General Statutes of North Carolina requires that the Town hold a public hearing prior to entering into the Agreement. If the Town Council of the Town so determines, an application will be submitted to the Local Government Commission of North Carolina for approval of the Agreement.

Please take notice that the Town Council of the Town will conduct a public hearing in the Council Meeting Room at the Town Hall located at 124 E. Wade Street in Wadesboro, NC, at its meeting beginning at 5:00 p.m. on September 27, 2016, at which time any person may be heard regarding the proposed Agreement described above. Following the public hearing, the Council may take action related to the approval of the financing agreement, adopt any related resolutions or other paperwork, and direct staff to take related action as needed.

A 26 year old man from Laurel Hill, NC drowed at Blewett Falls Lake on Tuesday, September 6. The man, Hernandez Salinas Carlos Miguel, was swimming with a friend when he went underwater and didn't come back up.

The friend called for help at 4:50 p.m. which resulted in a response from the Anson County Rescue Squad, the Anson County Sheriff's Office, the Anson County Emergency Services, the Lilesville Fire Department, and the Cordova Fire and Rescue from Richmond County. Miguel's body was recovered by a diver in an area identified by the friend. as well as other activities.

Safe Kids Anson will offer free child passenger car seat checks and give out information during the event. Approximately 94% of children in Anson County are riding in a car seat improperly according to the latest Safe Kids Anson evaluation.

Also during the event an Operation Medicine Drop will be held. At this station people can bring expired or unused prescription drugs to be properly discarded to keep medications from being misused and in the hands of children and young adults.

These are just a few of the services that will be on hand that day. Many more organizations that help protect you and your family will be there informing you of their services. Information will be handed out at different stations throughout the day.
