No matter the age you never stop praying for a child's safety and wellbeing.

On April 6, 2012, 23-year-old Jami Pless was killed in an automobile accident here in Wadesboro. Jami worked locally at Salon 52 with owner Kim Pugh. Before she died, Jami's boyfriend Jake Thomas, who teaches and coaches at our local high school, began introducing her to Anson County. Jami made many friends and loved it here.

A friend of Jami and her family has a young child whose name is Angel. Sadly nine-year-old Angel has been battling pediatric brain cancer and is undergoing chemotherapy. But, as you very often hear, patients are the ones who see what nospitals truly look like, what the effects hospital stays have on children who are admitted.

Angel noticed many children who had no visitors and nothing fun to do. So it became her mission to begin a childrens' game drive and to reach out to area communities in hopes of collecting games to give to sick children. "Gifts From Angels"

is a program founded by Angel and her parents. Last year Angel worked very hard, as well as her family and friends to collect and distribute the games. Some were even distributed to Anson Community Hospital's emergency room, since there is no local children's ward.

With the drive underway and the untimely death of Angel's family friend Jamie, the game drive became even more meaningful. "Angel has had a very rough year and has not been able to be as active as she wished," said Paula Fox, Jami's mother. 'So we would like to honor Jami's memory by helping Angel do what she started out to do. The game drive will continue through September and October and end on November 2, which would have been Jami's 25th birthday. This is something Jami would want us to do, and we are working hard to help Angel accomplish what she started.

Drop off sites for the drive are plentiful, so if you would like to donate a children's game or two, you can do so at Salon 52 located on Highway 74 in Wadesboro, all fire stations in Albemarle, Cabarrus County EMS and Stanly County EMS-Red Cross.

This drive is not only about Angel and Jamie, but so many others as well. Illness and tragic accidents can happen to anyone at anytime. "The loss of Jami has been unimaginable," said Jami's mom. "One way we have dealt with that loss is to try and make a difference in the lives of others. Sometimes we do not understand how fragile the gift of life is until it is taken away in a split second. Losing my child has taken a part of me that I will never recover. But, it also makes me responsible for carrying on her loving spirit for as long as I live." And so Gifts From Angels is important for many, many reasons.

In speaking with Kim Pugh she shared, "Jamie loved people, loved life and loved her family. Through her work at my salon, her work with Becky Tyson and her relationship with Jake, she made many friends in Anson County. She often went out of her way to help others. She shared her smile every day. She was fun loving and was especially close to her sister Alex. I know she would be proud of the efforts going on in her memory.

Gifts From Angels can help to spread the love of a very sick child, which is where this all began two years ago. Gifts From Angels can also share the spirit of a young lady whose life was cut short in the wake of a car accident. These two lives can help reach many others through their caring, giving natures. Both who would love it, appreciate it and be excited by the gifts received in their honor by YOU.

Share in the love and give generously to this game drive. There are so many children who need you. There are Angels in Heaven steering you in the direction of this path. #### Spotlight on Anson Cooperative Extension Agents

Their dedication to and work for Anson citizens benefits all of us either directly or indirectly. This week's spotlight is on Community Rural Development - Janine Rywak, County Extension Director.

From Janine Rywak: Anson County Cooperative Extension serves as administrator for the county's Voluntary and Enhanced Voluntary Agricultural Districts Program. Overseeing the county's ordinance, Cooperative Extension works with the 12-member appointed Anson Agricultural Advisory Board to enroll land, educate the public about farmland preservation, and advocate the importance of maintaining the county's agricultural areas.

In its third year, the program has enrolled over 10,000 acres, representing 127 tracts on 46 farms. This year the board recommended and the County Commissioners approved amending the county ordinance, bringing it in line with new state statues, to remove the requirement that land be enrolled in present-use value to qualify.
