Three Anson County Men Arrested for Dealing Cocaine and Meth



the Federal Bureau of Investigation filed a criminal complaint in district court after arresting well known Polkton businessman Cliff Martin, Jr. along with two other men, Michael Faulkenberry and Timothy Bowens, on drug charges. The men have been charged with buying and selling cocaine and methamphetamine. The FBI has classified this as a major investigation into the drug operation which

was based at 15 West Polk Street in Polkton, in close proximity to the Polkton Police Department and a church. The address is the location of Martin's business office. The FBI described Martin as the 'mastermind' of the drug ring. The complaint stated that

the investigation began in early 2015 after the FBI had contact with a confidential source who came forward about alleged drug deals. According to the complaint, the source told agents that he sold Martin cocaine in half



for Martin's phone in June 2016 and it revealed communications with several people, including Faulkenberry and Bowens, involving multiple transactions where Martin allegedly bought and sold cocaine. The complaint also stated that in November 2016 the

FBI developed a second confidential source who told investigators that Martin was 'a kilogram-level dealer and Faulkenberry was his runner.' That source was used to buy drugs at 15 West Polk Street numerous times.

In June 2017 the FBI was authorized to intercept Faulkenberry's phone conversations, resulting in recordings of numerous drug transactions.

In July 2017 the FBI was authorized to intercept Martin's cell phone communications, also resulting in recordings of numerous drug transactions. The complaint states that Martin referred to the drugs in terms such as "7 quarts of oil," "cake," "7 pieces of wood," "8 ball" and a "whole one." The FBI stated that they believe the "7" refers to \$700 or half an ounce of cocaine, and that a "whole one" may be refering to an ounce of cocaine, or even a kilogram of cocaine (2.2 pounds), which is valued between \$32,000 and \$38,000 according to Faulkenberry in an intercepted phone call.

Martin was approached by FBI agents on Monday, September 25 and told about the investigation. He agreed to make drug buys from two of his suppliers using FBI funds, one of whom was Bowens. The next day, on September 26, Bowens was picked up by the FBI, and he confessed to selling cocaine to Martin over the past year, including an ounce the night before.

According to an area news outlet, Polkton Police Chief Matthew Norris said Martin and Faulkenberry have been known to officers for some time. "Cliff and Michael have been a cancer on this community for a number of years and it's about time they got a dose of their own medicine," Norris said.

The three men are charged with conspiracy to possess and distribute Schedule I and II substances, and possession with the intent to distribute Schedule I and II controlled substances They were ordered to be held without bond, with a first court hearing on Monday, October 2. As of press time, the results of that court hearing are not known. The men face 10 years to life in prison and fines in excess of \$10 million.

Polkton Man Arrested in Child Predator Bust in Lincoln County

Michael Lee Williams of Polkton was charged with soliciting a minor for sex along with five other men in Lincoln County, NC according to a September 12 release from the Lincolnton Police Department. The six men were arrested for allegedly attempting to have an 'unlawful sexual relationship' according to police.

The arrests took place when the men arrived at a predetermined location that had been set up by undercover detectives posing as minors on social media. These arrests were the culmination of a two month investigation.

Police released this statement Tuesday: Parents are strongly encouraged to go through each follower and friend on their child's social media account and make sure your child knows them. If not, that person needs to be deleted. Parents must also be extremely cautious of fake and cloned profiles of people on social media. Parents must also be aware of what their child is doing on their smart phones and tablets.

The six men were each taken to the Lincoln County Jail. Robert Richard Quigg, of Valdese, was charged with two counts of soliciting a minor for sex and appearing. Police say Quigg was already listed as a registered sex offender. He was given a \$100,000 bond.

Loy Everette Huckle, of Dallas, was charged with one

- count of soliciting a minor for sex and appearing and one count of disseminating obscene material to a minor. Devin Cole Mayberry, of Statesville, was charged with
- one count of soliciting a minor for sex and appearing. • Timothy Harold Purley, of Newton, was charged with

Peachland Man Arrested After Two State Pursuit

Darlington County, South Carolina law enforcement officers arrested an Anson County man in Society Hill, SC after a chase that covered three counties in North and South Carolina. Law enforcement officers from several agencies were involved in the pursuit and manhunt for Ronald Alan Wittig, 20, of Peachland.

According to reports, the chase began in the afternoon on Friday, September 29 in Richmond County, NC. Law enforcemen officers pursued Wittig south through Bennettsville, SC and Marlboro County, then into Darlington County. Wittig stopped his vehicle at the boat landing in Society Hill, got out and ran into the woods. After a manhunt involving officers and K9 units, Wittig was found on Williamson Street in Society Hill and arrested at about 6 p.m. on Friday.

A release from the Darlington County Sheriff's Office stated that Sheriff Tony Chav and several of his deputies with the assistance of the Marlboro County Sheriff's Office, the Florence County Sheriff's Office Aviation Unit and K9 Unit, the Bennettsville Police Department, the Society Hill Police Department, the Lake City Police Department K9

Unit, and the Department of Natural Resources captured Wittig and took him into custody. Wittig was wanted in North Carolina for multiple felony warrants. He now faces new charges related to this incident.

Anson's August Unemployment Rate Remained a Low 5.3%

Anson County's unemployment rate continued at a low number for August, 5.3%, the same rate as July. Statewide the unemployment rate was 4.5% in August, also the same as July. Anson's total labor force in August was 10,261. Of that number 9,716 were

employed and 545 were unemployed. In July the total labor force was 10,386 with 9.837 employed and 549 unemployed. Unemployment rates (not seasonally adjusted) increased in 26 of North Carolina's

counties in August, decreased in 25, and remained unchanged in 49. Scotland County had the highest unemployment rate at 7.7 percent, while Buncombe County had the lowest at 3.4 percent. One of the state's metro areas experienced a rate increase, three experienced

decreases, and 11 remained unchanged. Among the metro areas, Rocky Mount at 6.6 percent had the highest rate and Asheville had the lowest rate at 3.7 percent. The August not seasonally adjusted statewide rate was 4.5 percent. When compared to the same month last year, not seasonally adjusted unemployment

rates decreased all 100 counties. $\,$ All fifteen metro areas experienced rate decreases over The number of workers employed statewide (not seasonally adjusted) decreased in August by 49,310 to 4,685,972, while those unemployed decreased 2,281 to 218,650.

Since August 2016, the number of workers employed statewide increased 74,052, while those unemployed decreased 36,937.
