Anson County Covid-19 Update

Ansonians urged to get vaccinated.

Flu shots now available at the Health Department.

The latest information posted by the Anson County Health Department on Monday, October 11 showed 3,780 total Covid-19 cases, with 95 active. There was an additional death from Covid-19 last week, bringing the total deaths to 77.

Vaccines are available, including walk-in clinics. They are free, and all you have to do is call the Health Department at 704-694-5188 for more information.

Now free testing is available Monday through Friday, 8 a.m. to 6 p.m. without an appointment. Testing takes place in the old hospital parking lot on Morven Road. They are testing Monday to Friday, from 8 a.m. to 6 p.m. No appointment is needed and there is no charge for the Covid test. Results will be called or emailed directly to the person tested or, in the case of children, to their parent or adult caregiver, in 2-3 days. They will test anyone over the age of 1.

Flu Shots The Health Department is offering both the regular flu shot and the high dose flu shot, for those 65 and over, on Monday and Wednesday afternoons, between 1:30 and 4 p.m. No appointment is needed. Just come on over to the Health Department with your ID and your insurance card and they will take care of you.

The NC Department of Health and Human Services (NCDHHS) reported that statewide as of Monday, October 11 there were 1,786 new cases, with 17,207 deaths and 2,152 hospitalized. 670% of adults in NC had at least one dose of vaccine, 65% were fully vaccinated.

Statewide, as of Monday, September 27 there were 2,665 new cases, with 16,235 deaths and 3,012 hospitalized. 69% of adults in NC had at least one dose of vaccine, 64% were fully vaccinated.. August 30 there were 4,569 new cases, with 14,412 deaths and 3,509 hospi-talized. August 2 there were 2,190 new cases, with 13,670 deaths and 1,359 hospitalized. July 12 there were 562 new cases of COVID-19, with 13,499 deaths and 448 hospitalized. On June 7 there were 359 new cases of COVID-19, with 13,199 deaths and 546 hospitalized. May 3 there were 1,126 new cases of COVID-19, with 12,691 deaths and 1,007 hospitalized. April 5 there were 1,054 new cases of COVID-19, with 12,173 deaths and 907 hospitalized. March 1 there were 862,170 cases of COVID-19, 11,254 deaths and 1,219 hospitalized. February 1: 761,302 cases, 9,342 deaths and 2,781 hospitalized. January 4: 570,111 cases, 6,941 deaths and 3,192 hospitalized. December 7: 404,032 cases, 5,605 deaths and 2,373 hospitalized. November 2: 278.028 cases, 4,390 deaths and 1,146 hospitalized. October 5: 219,754 cases, 3,637 deaths and 971 hospitalized.

Burglary, Kidnapping, Other Charges

During the October 4, 2021, session of Anson County Criminal Superior Court, a jury returned verdicts of guilty against defendant Mark Jones on the charges of first-degree burglary, robbery with a dangerous weapon, two counts of second-degree kidnapping, conspiracy to commit robbery,

conspiracy to commit burglary and conspiracy to commit second-degree kidnapping, felony larceny and possession of a stolen motor vehicle.

The trial lasted for three days and was tried by Assistant District Attorney T. Matthew Victory. Detective Shane Drake with the Anson County Sheriff's Office investigated the case that involved an armed home invasion of three victims: an adult male, adult female and a six year old child.

This was the first criminal case tried in Anson County since the COVID-19 Pandemic and the newly formed District 21 which includes Anson, Richmond and Scotland Counties.

District Attorney Reece Saunders said, "Crimes that involve violence, and especially those that involve the use of dangerous weapons, are priorities for prosecution in my office. We will fight for appropriate prison sentences.

The Honorable Stephan R. Futrell presided over the case and sentenced Jones to a minimum of 292 months and a maximum of 400 months in the North Carolina Department of Adult Corrections. The sentence converts to not less than 24.3 years and no more than 33.3 years.

Human Trafficking: A Survivor's Story

Connections, a family support program of Sandhills Center in collaboration with North Carolina Families United is presenting a program on human trafficking, and a survivor will share her story. The program will be on WebEx on Friday, October 22, from 1:30 to 3 p.m.

The presenters are Judith Paparozzi, Adjunct Professor at UNC-Pembroke and Lilliana Cox, a survivor of human trafficking.

Lilliana will share her story about how she was ensnared in human trafficking by a "friend" as she evacuated her Wilmington home due to Hurricane Florence in 2018, and how she escaped her trafficker in 2019. Lilliana will also tell you how she not only survived human trafficking, but she testified and put her trafficker, Markus McCormick, in prison in 2021.

Also, UNCP Adjunct Professor Judith Paparozzi will share tips on how to keep teens and young adults safe while online.
