Anson Landfill Expansion

With the intent of expanding the landfill capacity more than twofold, the North Carolina Department of Environmental Quality has issued a draft permit for the proposed horizontal and vertical expansion of the Anson Landfill.

This would increase the disposal area from 133.10 acres to 198.44 acres and the maximum landfill height would be raised by 70 feet, taking the total capacity from 21.6 million cubic yards to an alarming 41.5 million cubic yards.

This expansion is deeply concerning and we urge all citizens of Anson County to attend this public hearing.

Your voice matters, and we must act together to protect our environment and ensure that the Anson Landfill does not increase its capacity to unacceptable levels. We urge you to come and speak up for the safety of Anson County and beyond.

Bids will be accepted beginning Friday, October 27th at Town Hall (114 East Wall Street), all bids received initially will be opened on Monday, November 6th at 6:00p.m. at the Lilesville Fire Department.

This sale will be performed through an "upset bid" process pursuant to NCGS 160A-269 – "When an offer is made and the council proposes to accept it, the council shall require the offeror to deposit five percent (5%) of his bid with the city clerk, and shall publish a notice of the offer. The notice shall contain a general description of the property, the amount and terms of the offer, and a notice that within 10 days any person may raise the bid by not less than ten percent (10%) of the first one thousand dollars (\$1,000) and five percent (5%) of the remainder. When a bid is raised, the bidder shall deposit with the city clerk five percent (5%) of the increased bid, and the clerk shall readvertise the offer at the increased bid. This procedure shall be repeated until no further qualifying upset bids are received, at which time the council may accept the offer and sell the property to the highest bidder. The council may at any time reject any and all offers."

All bids and updates will be posted promptly at the Town Hall.
