720 Reported Cases of COVID-19

Health Department encourages everyone to wear a mask to protect themselves and others

On Tuesday, October 20 the Health Department reported another death, bring the county total to nine deaths. As of Monday, October 26 the Anson County Health Department posted that Anson County had 720 reported cases of COVID-19. 41 of those cases were active. At that point they had discharged 679 cases, 670 to baseline health and nine deaths

In a release the Health Department stated, "With the number of cases rising in our state, we would like to encourage people to take a part in protecting themselves and others. Remember to wear a mask, keep distance from others, wash your hands often, and download the free SLOWCOVID app. Learn more about the notification app at covid19.ncdhhs.gov/SlowCOVIDNC. #StayStrongNC. Let's all do our part!'

The NC Department of Health and Human Services (NCDHHS) reported statewide as of Monday, October 26 there were 261,742 total cases of COVID-19, with 4,170 deaths, 3,863,108 completed tests and 1,193

As of Monday, October 19 there were 247,172 total cases of COVID-19, with 3,939 deaths, 3,640,086 completed tests and 1,142 currently hospitalized, and as of October 13 there were 234,481 total cases of COVID-19, with 3,816 deaths, 3,437,598 completed tests and 1,103 currently hospitalized. On Monday, October 5 there were 219,754 total cases of COVID-19, with 3,637 deaths. 3,188,371 completed tests and 971 currently hospitalized Recent history in Anson County: March 31 - 1 cases April 28 - 23 cases; May 26 - 62 cases; June 22 - 107 cases; July 27 - 285 cases; August 3 - 306 cases; August 9 - 328 cases; August 19 - 376 cases; August 26 - 408 cases; September 4 - 461 cases; September 14 - 513 cases; September 21 - 553 cases; September 28 -605 cases; October 5 - 649 cases; October 12 - 670 cases; October 19 - 692 cases.

Candlelight Vigil October 29 to Remember Victims of Domestic Violence

October is Domestic Violence Awareness Month. According to the National Coalition Against Domestic Violence (NCADV) website, Domestic Violence Awareness month was first observed in 1987. Anson County Domestic Violence and Rape Crisis Center (ACDVC) participates in the Silent Witness program during the month of October to mourn those who have died because of domestic violence, celebrating those who have survived, and connecting those who work to end violence.

During October life-sized wooden figures will be placed in the county, each one bearing the name of a person who once lived, worked, had friends and family - whose life ended violently at the hands of a partner, spouse,

ex-spouse or acquaintance. Gail Dove from ACDVC said, "Domestic Violence often

goes unreported. In Anson County, from July 2018 to June 2019, ACDVC assisted 347 victims of domestic violence; 309 were female and 38 were males. The age bracket with the highest incident is 26-40 years old. We had 441 calls to our crisis hotline. According to statistics, one in three women and one in four men have been victims of some form of physical violence by their intimate partner. According to the North Carolina Coalition Against Domestic Violence, every nine seconds a woman is assaulted. From October 1, 2018 to September 30, 2019 there were 52 domestic violence related deaths in North Carolina alone.

On Thursday, October 29 at 6:00 p.m. a candlelight vigil will be held at the front steps of the Anson Courthouse. ACDVC invites anyone who has a friend or loved one represented here or if you have been or know someone that has been affected by domestic violence to come and join everyone during this special time of remembrance.

This year's vigil will be a little different than previous years due to the COVID-19 pandemic, but the public is asked to still come out in support of victims and their families. ACDVC asks that you wear a mask and observe social distancing precautions.

On Wednesday, October 21 Governor Roy Cooper announced that North Carolina will remain paused in Phase 3 for three more weeks as health officials continue to monitor North Carolina's viral trends. North Carolina has seen increased hospitalizations and trajectory of cases in recent weeks. Governor Cooper underscored the importance of wearing masks, social distancing, and using good judgment despite fatigue or frustration with the pandemic. "As this pandemic continues, I know it's difficult and tiring to keep up our guard,

especially when we're gathered with people we love. But it's necessary. No one wants to spread COVID-19 accidentally to friends or family, so we must keep prevention at the forefront," said Governor Cooper. "Wearing a mask shows you care about people. Also today, Governor Cooper updated on progress with the NC Housing Opportunities

and Prevention of Evictions (HOPE) program. Since Governor Cooper announced the (HOPE) Program last week, 12,000 eligible applicants have filed for assistance. The HOPE Program provides assistance to eligible low-and-moderate income renters experiencing financial hardship due to the pandemic by making direct payments to landlords and utility companies. 
