Anson County Added to Counties Approved for Disaster Unemployment Assistance

The Division of Employment Security (DES) has announced that Anson County, Carteret County, Chatham County, Northhampton County, Perquimans County, Richmond County, and Scotland County have been approved for Disaster Unemployment Assistance (DUA) due to the effects of Hurricane Matthew. This brings the total to 45 counties that have been approved for DUA. Additional counties may be added to the DUA availability designation at a later date.

In order to assist citizens in this State that have suffered losses and are likely to suffer imminent further widespread losses, Governor Pat McCrory has directed DES TO NOT ENFORCE the one-week waiting period and job search requirements for individuals whose employment or self-employment has been lost or interrupted as a direct result of a major disaster in the counties approved in the President's declaration. Individuals from these counties who are affected by the disaster and are unable to continue working must file an application for benefits by December 5, 2016.

Workers who became unemployed as a direct result of the effects of Hurricane Matthew impacting North Carolina, may be eligible for unemployment insurance benefits under the DUA program. Business owners affected by the storm may also qualify for benefits. Workers or business owners meeting the following criteria may be eligible for benefits:

- Individuals who are unemployed due to the disaster, and do not qualify for regular unemployment insurance benefits. If you are eligible for regular unemployment insurance benefits, you must first exhaust those benefits before you are eligible for DUA.
- Self-employed individuals and small business owners who lost income due to the disaster.
- Individuals who were prevented from working due to an injury caused by the disaster.
- Individuals who have become the major supplier of household income due to the disaster-related death or injury of the previous major supplier of household income.
- Individuals who are unable to reach their job or self-employment location because they must travel through the affected area and are prevented from doing so by the disaster.
- Individuals who were to commence employment or self-employment but were prevented from doing so by the disaster.

DUA is funded entirely by the federal government. Individuals need to file first for regular unemployment insurance. If an individual is determined ineligible for regular unemployment insurance, or has exhausted their regular unemployment insurance benefits, a DUA claim can then be filed. Individuals will need their Social Security number, copies of their most recent federal income tax forms or check stubs, or documentation to support they were working or self-employed when the disaster occurred. To receive DUA benefits, all required documentation must be submitted within 21 days from the day the DUA application is filed.

DUA is available for weeks of employment beginning with the week starting October 9, 2016, and lasting for up to 26 weeks, as long as the claimant's unemployment continues to be as a result of Hurricane Matthew.

Individuals may contact DES by calling 1-866-795-8877 from 8AM to 5PM to apply for DUA benefits. Individuals are encouraged to file as soon as possible. If you are self-employed, you will be required to submit your most recent Federal Income Tax returns and/or your profit and loss statement to establish your weekly amount. Anson County Farmers May Qualify for FSA EM Loans Due to Flooding

On Thursday, November 3 President Obama declared a major disaster in the State of North Carolina based on losses caused by Hurricane Matthew that occurred October 4 and continuing. As a result of this major disaster, seven North Carolina counties were declared eligible for Federal disaster assistance, including Farm Service Agency (FSA) emergency (EM) loans for eligible family farmers.

Anson County is one of the seven primary disaster counties. The other primary disaster counties are: Carteret, Chatham, Northhampton, Perquimans, Richmond and Scotland.

In addition to those seven primary disaster counties, 26 additional North Carolina counties are named as contiguous counties where eligible family farmers may qualify for FSA EM loan assistance. Those counties are: Alamance, Bertie, Chowan, Craven, Durham, Gates, Halifax, Harnett, Hertford, Hoke, Jones, Lee, Montgomery, Moore, Onslow, Orange, Pamlico, Pasquotank, Randolph, Robeson, Stanly, Tyrrell, Union, Wake, Warren and Washington.

Suzanne Simpson of the Farm Service Agency said that effective November 3, 2016, farmers in Anson may apply for EM loans for physical and production losses. July 3, 2017, is the deadline for filing an application. Affordable Care Act Open enrollment Kicked Off Nov. 1

North Carolinians can enroll or re-enroll in health insurance plans through the Health Insurance Marketplace through January 31, 2017

North Carolinians can enroll or re-enroll in quality, affordable health coverage through the Health Insurance Marketplace when the fourth open-enrollment period for the Affordable Care Act begins on Tuesday, Nov. 1.

During the open-enrollment period, which runs from Nov. 1 to Jan. 31, uninsured North Carolinians will be able to enter the Health Insurance Marketplace and select plans that fit their needs and budgets. People who currently have coverage through the Marketplace should check the website to learn about new options and ensure they are getting the correct amount of financial help for 2016.

For many North Carolinians, affordability is a real concern in their health care decision-making. In the past, high premium costs have forced many to go without health insurance simply because they could not afford it. The good news is that financial assistance is available to help people pay for plans – in fact, 92% of North Carolinians who signed up for Affordable Care Act coverage received financial assistance to make their plan more affordable.

The NC Navigator Consortium and Enroll America are urging North Carolinians to check out Affordable Care Act plans. In the last enrollment period, over 613,000 N.C. residents enrolled in health coverage through the Marketplace, providing them with the peace of mind that comes with protecting themselves and their families. This coming open-enrollment period is the next opportunity North Carolinians have to take advantage of the coverage options available through the Marketplace.

"We encourage North Carolinians to check out their health care coverage options in the upcoming enrollment period," said Jennifer Simmons, director of the NC Navigator Consortium. "We have in-person assisters in all counties across North Carolina who can sit down face-to-face with consumers for free to answer questions and help them make the best coverage decision for them and their families."

North Carolinians can find free in-person assisters available in their communities by calling 1-855-733-3711 or using the Get Covered Connector tool at www.getcoveredconnector.org. In-person assisters in Eastern North Carolina will accommodate scheduling needs of people affected by Hurricane Matthew.

Enroll America's North Carolina State Director Sorien Schmidt said North Carolinians who are losing coverage because their insurance providers are leaving the Marketplace should take advantage of the available in-person assisters and review plans that are still available to them. "There are still many health insurance options for North Carolinians through the Marketplace and we encourage those who need to re-enroll to review plans available to them," said Schmidt. "We will continue working as a team to reach out to the uninsured wherever they are with the information they need to get covered and make them receive the most up-to-date financial package available to them."

While the fourth open-enrollment period provides an opportunity for North Carolinians to gain access to quality, affordable health care, it also gives people a chance to avoid paying a fine when they file their taxes. Those who do not enroll in a plan by Jan. 31, 2017, could face a fine of \$695 or 2.5% of their yearly income, whichever is greater.
