Registering for Job Search Remains a Requirement to **Receive Unemployment Benefits**

The Division of Employment Security is reminding claimants that Employment Security Law requires registering for work in order to receive unemployment benefits. Claimants may do so through NCWorks Online. Claimants are required to complete a full registration for work at NCWorks Online (www.ncworks.gov) in order to meet their work registration requirement for unemployment insurance benefits. The work registration must include the completion of the Resume Builder tool, which allows claimants to input their employment history and occupational skills. The claimant must also maintain an active NCWorks

Online account by accessing the system every 90 days to update and/or validate their resume. NCWorks Online is a one-stop online resource for job

seekers and employers in North Carolina. Job seekers can search for jobs, create resumes, and find education and training. Employers can find candidates, post jobs, and search labor market information. NCWorks Online has over 103,000 job postings and regularly receives more than 5 million page views a week. Claimants who fail to complete registration at NC-

Works Online or do not have an active account will receive a message indicating that they need to register for work when they attempt to complete their weekly certification for benefits via telephone or the internet. If a person has not yet filed a claim for unemployment insurance benefits, they must register for work at www.ncworks.gov. They can then file a claim for unemployment

benefits at www.ncesc.com. An automated process will be used to determine that the work registration has been completed or the NC-Works Online account re-activated. Once registered, the claimant will be able to complete their weekly certification on the next business day following the completion of the requirement.
