It's one of the busiest times for law enforcement because some many people are out shopping, visiting and enjoying the season. However, these factors and the usual distractions of shopping create a favourable environment for thieves and robbers who are out to take advantage every chance they get. Our home break-ins will double or triple over the next two months. Cars in shopping centers and sometimes drive-ways will be broken into when gifts and packages are left inside them.

A single shopper is the best target for theft. Always shop with a friend or relative. Tell someone where you are going and what time to expect you to return. Make sure they know what you are wearing and the type of vehicle you are driving. Shop during daylight hours when possible. If you do shop at night park in a well-lit area. Dress casually and comfortably and avoid wearing expensive jewelry. Keep car keys in a pants or jacket pocket.

Always pay careful attention to your surroundings. When returning to your vehicle, check around it and in the back seat. Have your car keys in your hand to avoid spending unnecessary time outside your vehicle. If you feel uneasy returning to your vehicle alone, find a security guard and ask them to walk you to your car. Always store purchased items in a trunk or back storage area of SUVs where they cannot be seen.

### **United States Department of Agriculture Issues** Conservation Reserve Program, Rental Payments, Direct Payments

Anson County producers could benefit

Agriculture Secretary Tom Vilsack announced that USDA has begun distributing Conservation Reserve Program (CRP) annual rental payments to participants across the country. USDA also will distribute 2013 direct payments beginning October 24. Payments originally were scheduled to be issued earlier in the month, but were delayed by several weeks due to the lapse in Federal funding.

"Farmers, ranchers and rural landowners across the country count on USDA programs and the payment delays due to the shutdown were an unnecessary burden," Vilsack said. "USDA has prioritized making these scheduled payments without any further delay and Farm Service Agency staff have worked hard to get this assistance out the door as quickly as possible."

Producers will receive payments on almost 700,000 CRP contracts on 390,000 farms covering 26.8 million acres. In

exchange for a yearly rental payment provided by USDA on contracts ranging from 10 to 15 years, farmers and ranchers enrolled in CRP agree to remove environmentally sensitive land from agricultural production and plant grasses or trees that will improve water quality and improve waterfowl and wildlife habitat. CRP reduced runoff and leaching of nitrogen and phosphorus into waterways by an estimated 605 million pounds and 121 million pounds, respectively, in 2012, and soil erosion reductions totaling 308 million tons in 2012.

Direct payments for 2013 for the DCP programs are being made to the more than 1.7million farms enrolled in the Farm Service Agency's programs. Producers with base acres of certain commodities are eligible for DCP payments.

The 2008 Farm Bill, extended by the American Tax Payer Relief Act of 2012, provides authority to enroll land in DCP, ACRE and CRP through Sept. 30, 2013, however, no legislation has been enacted to reauthorize or extend this authority. Effective Oct. 1, 2013, FSA does not have legislative authority to approve or process applications for these programs.
