On Tuesday, November 11 officers of the Wadesboro Police Department were investigating a breaking and entering case when they observed the suspect vehicle in the area of Wade Manufacturing. Officers conducted a traffic stop and approached the vehicle where they observed that there were three suspects inside the vehicle. After a brief conversation with the suspects, officers observed materials that are consistent with manufacturing methamphetamines. During a more thorough investigation officers observed where the suspects attempted to discard the materials on the ground outside of the vehicle. A search warrant was executed on the vehicle where a methamphetamine lab was discovered. The suspects were arrested and charged accordingly.

Anson County's 911 Dispatcher LaShonda Spencer Takes Care of Business!

On Saturday, September 27 at 5:45 p.m. an urgent call from the Lilesville area came into 911 of a young lady, Latavias Bennett, going into labor. Anson County dispatcher LaShonda Spencer took the call and immediately dispatched Lilesville First Responders and EMS. Then, using Emergency Medical Dispatch (EMD) protocol, Spencer began talking Latavias' aunt, Hallie Bennett through the birthing process. By the time First Responders arrived at the scene the baby, a six pound, seven ounce baby boy was born and resting with its mother.

"This is what the dispatchers are trained to do," said Sheriff Tommy Allen. "When we went to EMD several years ago we raised the bar significantly for emergency service calls in Anson County. This was not our first baby birth but this was a good example as to how the system works and it works quite well. In addition to birthing babies, we have talked individuals

through CPR, stopping bleeding, what to do for choking and other lifesaving procedures." Sheriff Allen continued, "My 911 staff is really good. They stay calm when everything and everyone around them is anything but calm. Anson County is very fortunate to have a 911 operation of this quality. I'd put my staff up against any in this state or country.

For now, mother and baby are both doing fine. Dispatcher Spencer met Ms. Bennett, baby Landon and Aunt Hallie Bennett over at the 911 Center this week in a meeting arranged by Sheriff Allen.

New Office Hours at Cooperative Extension Office

The Anson County Cooperative Extension Center will be operating under new office hours in 2015. Beginning January 1 the office will be closed during the hours of 12 noon until 1 p.m.

A statewide reorganization has created staffing changes that will impact office coverage. To be able to meet client requests and program demands the local office will be closed to the public for lunch. During that time telephone calls will be received by an automatic operating system and returned after 1 p.m. However, meetings scheduled at the Extension Center during lunch hours will still be allowed.

In addition, due to scheduling and work load, at various times only one staff member may be available to man the office. During those times the door will be locked with a sign indicating that clients should ring doorbell for entry.

These new operating procedures are intended to maintain customer service standards, while providing for the professional and safety needs of the Extension staff. Clients are asked to understand these challenges and work with staff through the new changes.
