Flu shots are available at the Health Department.


Information posted by the Anson County Health Department on Friday, November 19 showed 4,015 total Covid-19 cases (only 10 more than 11/15), with 64 active. The total deaths are 84.

Vaccines are available for everyone 5 years old and older, including walk-in clinics. (Children 5-11 by appointment only.) Vaccine boosters are available. They are free, and all you have to do is call the Health Department at 704-694-5188 for more information. Walk-in clinics are on Tuesdays and Thursdays, 8:30 to 11:00 a.m. and 1 to 3:30 p.m.

The NC Department of Health and Human Services (NCDHHS) reported that statewide as of Sunday, November 21 there were 2,401 new cases, with 18,597 deaths and 1,052 hospitalized, up significantly from last Monday (November 15) with 1,361 new cases. 72% of adults

## Carnell Charles Caple, Jr. is **Sentenced to More than Six Years** on Federal Drug and Gun Charges

Acting U.S. Attorney William T. Stetzer announced that Carnell Charles Caple, Jr., 32, of Wadesboro was sentenced to 76 months in prison and three years of supervised release on federal drug and gun charges.



of the Wadesboro Police Department join Acting U.S. Attorney Stetzer in making today's announcement. According to court documents and the sentencing

hearing, on November 12, 2020, a Wadesboro Police Department detective conducted a traffic stop of the vehicle in which Caple was riding as a passenger. Over the course of the traffic stop, the officer asked the driver of the vehicle to step outside and instructed Caple to remain in the car. Caple did not comply and instead attempted to flee on foot. Law enforcement at the scene observed Caple discard a black bag while he ran with a firearm in his hand. Shortly thereafter, Caple tripped and fell and was placed under arrest. According to court records, officers recovered Caple's firearm, which was loaded with 15 rounds of ammunition

and one additional round in the chamber. Law enforcement later determined that the firearm was stolen. Law enforcement also recovered Caple's black bag, in which they found narcotics, drug paraphernalia, and another magazine loaded with 10 rounds of ammunition. Court records show that at the time of the offense Caple was on supervised release for a previous federal offense.

On July 22, 2021, Caple pleaded guilty to possession with intent to distribute methamphetamine and cocaine, and possession of a firearm by a convicted felon. He is currently in federal custody and will be transferred to custody of the federal Bureau of Prisons upon designation of a federal facility.

Stetzer thanked the FBI and the Wadesboro Police Department for their investigation of the case. Assistant United States Attorney Regina Pack, of the U.S. Attorney's Office in Charlotte, prosecuted the case. This case is being prosecuted as part of the joint

This initiative is a first-of-its-kind plan that serves as a blueprint for how to implement

a robust, interconnected network combining high-capacity transit lines, enhanced bus service and other innovative mobility solutions. CONNECT Beyond will cover a diverse area, crossing the dashed lines that split the Charlotte region including 12 counties, two states, four Metropolitan Planning Organizations, one Rural Planning Organization and two state Departments of Transportation. 'Over the past two decades, our region has experienced unprecedented growth and

remained resilient through turbulent cycles. Access to safe, reliable, affordable and wellconnected public transportation is critical so that everyone can benefit from this economic prosperity," said Geraldine Gardner, Executive Director of Centralina Regional Council

Anson County is part of the plan's 12-county region which consists of Anson County, Cabarrus County, Cleveland County, Gaston County, Iredell County, Lincoln County, Mecklenburg County, Rowan County, Stanly County, and Union County in North Carolina and the urbanized areas of Lancaster County and York County in South Carolina.
