Emergency Loans Available for Anson County Farmers **Due to Hurricane Matthew**

On Tuesday, November 22 President Obama declared a major disaster in the State of North Carolina based on losses caused by Hurricane Matthew that occurred October 4, 2016 through October 25, 2016. As a result of this major disaster, 3 North Carolina counties were declared eligible for Federal disaster assistance, including Farm Service Agency (FSA) emergency (EM) loans for eligible family farmers. Those primary disaster counties are Montgomery, New Hanover and Pamlico.

additional North Carolina counties are named as contiguous counties where eligible family farmers may qualify for FSA EM loan assistance, in accordance with Section 321(a) of the Consolidated Farm and Rural Development Act. Those counties are Anson, Beaufort, Brunswick, Carteret, Craven, Davidson, Hyde, Moore, Pender, Randolph, Richmond, Rowan and Stanly.

In addition to those three primary disaster counties, 13

Disaster Unemployment Assistance Due to Hurricane Matthew

The Division of Employment Security (DES) has announced that Anson County has been approved for Disaster Unemployment Assistance (DUA) due to the effects of Hurricane Matthew. Anson County was added on November 4, 2016 for individuals who are affected by the disaster and are unable to continue working must file an application for benefits within 30 days (December 5, 2016).

In order to assist citizens in this State that have suffered losses and are likely to suffer imminent further widespread losses, Governor Pat McCrory has directed DES to not enforce the one-week waiting period and job search requireindividuals whose employment for self-employment has been lost or interrupted as a direct result of a major disaster in the counties approved in the President's declaration.

DUA is available for weeks of employment beginning

business owners meeting the following criteria may be eligible for benefits: Individuals who are unemployed due to the disaster, and

do not qualify for regular unemployment insurance benefits. If you are eligible for regular unemploy

ment insurance benefits, you must first exhaust those benefits before you are eligible for DUA.

 Self-employed individuals and small business owners who lost income due to the disaster.

 Individuals who were prevented from working due to an injury caused by the disaster.

 Individuals who have become the major supplier of household income due to the disaster-related death or injury of the previous major supplier of household income.

 Individuals who are unable to reach their job or self employment location because they must travel through the affected area and are prevented from doing so by the disaster.

 Individuals who were to commence employment or selfemployment but were prevented from doing so by the disaster.

DUA is funded entirely by the federal government. Individuals need to file first for regular unemployment insurance. If an individual is determined ineligible for regular unemployment insurance, or has exhausted their regular unemployment insurance benefits, a DUA claim can then be filed. Individuals will need their Social Security number, copies of their most recent federal income tax forms or check stubs, or documentation to support they were working or self-employed when the disaster occurred. To receive DUA benefits, all required documentation must be submitted within 21 days from the day the DUA application is filed. Individuals may contact DES by calling 1-866-795-

8877 from 8 a.m. to 5 p.m. to apply for DUA benefits. Individuals are encouraged to file as soon as possible. If you are self-employed, you will be required to submit your most recent Federal Income Tax returns and/or your profit and loss statement to establish your weekly amount.
