
Lilesville Community Festival is Saturday

Deadline is December 6 for Prose and Poetry Contests

The Anson County Writers' Club (ACWC) is accepting submissions for its annual con-tests in prose and poetry. The deadline is December 6, 2021. The contests are divided into adult, youth, and children's categories.

The adult contests are open to anyone residing in, having resided in, attending school in, or working in Anson County; or members of the ACWC. There is a \$1 entry fee that is waived for students at any institution of higher learning.

There is no entry fee for students in grades 3-12. Rules and entry forms will be provided to all Anson County schools. Home-schooled students are also invited to enter.

There are three ways to enter. Submissions in Word can be emailed to: info@anson countywritersclub.org with "contest" in the subject line; mailed to Anson County Writers Club, Box 363, Wadesboro, NC, 28170; or dropped off at the Hampton B. Allen Library. A complete copy of the rules and an entry form that must accompany each entry are available at the Library or by writing to ACWC 2021 Contests, P.O. Box 363, Wadesboro, N.C., 28170 (enclose a self-addressed, stamped envelope). Rules and entry forms may also be printed from the ACWC website at www.ansoncountywritersclub.org. Failure to follow the rules may result in an entry being disqualified.

The ACWC will award over \$400 in prize money to the winners of the annual writing contests. First, second and third place winners in the adult prose and adult poetry categories will receive \$50, \$30 and \$20, respectively. Youth winners (grades 9-12) will receive \$20, \$15 and \$10, respectively. Grades 3-5 and Grades 6-8 will compete separately in the children's division. Prizes are \$15, \$10 and \$5, respectively, for prose and poetry winners in both categories.

All winners will receive a certificate suitable for framing and will be honored at a reception for friends and family on Sunday, Feb. 27, 2022

The ACWC held its first contests in 1989 and since published 10 anthologies of the winning entries. Anson Pathways XI will be published in 2021.

Burn Ban Issued for All North Carolina Counties

Due to increased fire risk, the N.C. Forest Service has issued a ban on all open burning and has canceled all burning permits statewide effective at 5 p.m. on Monday, November 29 until further notice.

"It is fall wildfire season in North Carolina, and we are seeing wildfire activity increase due to dry conditions," said Agriculture Commissioner Steve Troxler. "With these ongoing conditions, a statewide burn ban is necessary to reduce the risk of fires starting and spreading quickly. Our top priority is always to protect lives, property and forestland across the state.


Under North Carolina law, the ban prohibits all open burning in the affected counties, regardless of whether a permit was previously issued. The issuance of any new permits has also been suspended until the ban is lifted. Anyone violating the burn ban faces a \$100 fine plus \$183 court costs. Any person responsible for setting a fire may be liable for any expenses related to extinguishing the fire.

Local fire departments and law enforcement officers are assisting the N.C. Forest Service in enforcing the burn ban.

The N.C. Forest Service will continue to monitor conditions. Residents with questions regarding a specific county can contact their N.C. Forest Service county ranger or their county fire marshal's office. Here are some questions and answers:

Q: What is open burning? A: Open burning includes burning leaves, branches or other plant material. In all cases, burning trash, lumber, tires, newspapers, plastics or other nonvegetative material is illegal.

Q: May I still use my grill or barbecue? A: Yes, if no other local ordinances prohibit their use.

Q: How should I report a wildfire? A: Call 911 to report a wildfire.

Q: How should I report a person who intentionally starts a wildfire? A: Call 911 to report a wildfire.

Q: My local fire marshal has also issued a burn ban for my county. What does this mean? A: The burn ban issued by the N.C. Forest service does not apply to a fire within 100 feet of an occupied dwelling. Local government agencies have jurisdiction over open burning within 100 feet of an occupied dwelling. The N.C. Forest Service has advised county fire marshals of the burning ban and has asked for their consideration of also implementing a burning ban. If a fire within a 100-foot area of a dwelling escapes containment, a North Carolina forest ranger may take reasonable steps to extinguish or control it. The person responsible for setting the fire may be liable for any expenses related to extinguishing the fire.

Q: Are there other instances which impact open burning? A: Local ordinances and air quality regulations may impact open burning. For instance, outdoor burning is prohibited in areas covered by Code Orange or Code Red air quality forecasts. Q: Can I have a campfire when I go camping? A: Campfires would be considered open burning and are not exempt from the burn ban. During a burn ban, portable gas stoves or grills are alternate methods for cooking food while camping.

Enrollment Open for Leadership Anson 2022

PURPOSE Leadership Anson was created to develop competent and skilled leadership for the challenging times ahead. This intensive, six-month leadership program provides participants with an overview of the theories and concepts of leadership, a knowledge of the opportunities and understanding of governmental agencies and community organizations at work in the county, consideration of historical and cultural influences and an open dialogue between emerging and current community leaders.

PROGRAM The Chamber of Commerce Leadership Program consists of 10 full-day sessions held two days a month from January to June. The sessions are held at various locations in Anson County that best relate to the topic. During each session, participants are introduced to issues by means of panels, lectures, tours, group discussions and simulations. In each case, the program is designed to address specific areas rather than vague concepts.

The topics covered in the Leadership Anson program are as follow: Leadership Skill Development; Local History and Geography; Economic Development; Law Enforcement, Fire & Rescue; Education; Human Services; Media; Health Services; Local Government; Agriculture.

PARTICIPANTS Participants are selected in an objective process with information presented on a completed program application. Selection criteria are:

- Motivation and commitment to serve the community
- Demonstrated leadership qualities

• An interest in participating in community projects upon completion of the series. NOTES The maximum capacity for each year's class is 20. Participants are required to attend the all-day and/or overnight retreat to graduate. Each participate can miss one class in order to graduate. Missed sessions must be made up within two years.
