#### New Law Allows Anson County Kids Under 12 to Use BB Guns Unsupervised

North Carolina laws that took effect Monday, December 1 will add protections for Venus flytraps, let children in eight counties shoot BB guns unsupervised and allow criminal defendants statewide to have their case decided by a judge instead of a jurv.

 Anson County is one of 8 counties in North Carolina that now allow children under 12 years old to possess and use BB guns, air pistols and air rifles without adult supervision. Most counties in NC already allowed this. The counties that do not are Caldwell, Durham, Forsyth, Gaston, Haywood, Mecklenburg, Stokes, Union and Vance Counties. A constitutional amendment that gives criminal defendants the right to decline a jury trial and have a judge decide their case instead is now law. Defendants have this option in 49 other states and in the federal criminal justice system, but North Carolina defendants previously couldn't waive the jury trial. Now, the judge would have to agree to allow a bench trial, and the option wouldn't be available in a death penalty case.

In a report, the UNC School of Government said bench trials tend to be shorter and less expensive than jury trials, but changing the system could concentrate power with judges and reduce citizen participation in the justice system. Under new law, the penalty for giving or selling a cellphone to an inmate is increased from a misdemeanor to a felony. It also makes it a felony for an inmate to possess a cellphone. Gov. Pat McCrory and other leaders pushed for stiffer penalties after the father of a Wake County prosecutor was kidnapped in a plot authorities say was directed by an inmate using a contraband cell phone. The kidnapped man was rescued by the FBI. Under legislation to change criminal laws, people caught multiple times carrying a concealed firearm without a permit will face felony charges for the second and subsequent offenses. The first such offense remains a misdemeanor. A provision of the Regulatory Reform Act increases the penalty for stealing a Venus Flytrap from a misdemeanor to a felony. Conservation groups asked for the stiffer charge after recent thefts of the plants in eastern North Carolina, which is one of the few native areas of the plant.

# Lanesboro Correctional Officer **Seriously Injured in Attack**

An inmate at Lanesboro Correctional Institution attacked an officer with a bladed weapon on Monday, November 24 which resulted in a cut to the officer's face requiring more than 40 stitches. The officer, Edwin Faulkner had released the prisoner, Marcus Alston, 37, from restraints to give him recreational time.

Alston faces charges in the attack and is segregated from other prisoners.

Alston, who is serving a 35 year sentence for rape, has been cited for 169 prison infractions since his 2001 conviction. He has threatened to harm prison staff on numerous occasions.

The Polkton Police Department and state prison officials are investigating the incident.

# **Conceal Carry Permits** Now Available Online

As of December 1 individuals wanting to apply for a Concealed Carry Permit or renew a Conceal Carry Permit will now go online to do so. This feature has been available to the public since the first of October, and for the past two months they had the option of either doing online or paper applications. Now the Sheriff will only accept online applications. Individuals who do not have access to a computer may still come by the Sheriff's Office and use a computer in the Sheriff's lobby. The Sheriff's Office will also have someone available to assist those who are not comfortable using a computer.

Outgoing Sheriff Tommy Allen said that this is similar to what the Sheriff's Office started doing with Handgun Permits a year ago. He said this streamlines the process, saves a lot of paperwork and will eliminate a lot of waiting and standing in line. Applicants will be able to schedule their own appointments on Thursdays to be fingerprinted.

"Our goal is to continue to serve the public better and more efficiently," Allen said.
