Answers to Commonly Asked Blood Donor Eligibility Questions

One of the things that keeps many people from donating blood is a misconception about their eligibility. In truth, there are very few things that may prevent an otherwise healthy person from donating. Here are some answers to commonly asked questions about donor eligibility:

• Can I give blood if I'm afraid of needles? Most people do feel a bit of nervousness about blood donation. Most also say after their donation that they're sorry

they waited so long. Blood donation is a momentary discomfort for the donor that can provide a lifetime of difference for the patient.

• Can I give blood if I recently got a tattoo or piercing? Piercings do not disqualify you from donating blood as long as they were done with single-use, disposable equipment. Tattoos also do not disqualify

you from donating if they were done with a single-use needle at a licensed facility.

 \bullet Can I give blood if I have high blood pressure or high cholesterol? As long as your blood pressure is below 180 systolic (first number) and 100 diastolic (second number) at the time of your donation, you

may give blood. Also, medications that you may be taking for high blood pressure do not disqualify you from donating. A high cholesterol level does not disqualify you from donating, even if medication

is used to control it.

• Can I give blood while I'm on medication? In nearly all cases, medications will not disqualify you as a blood donor. As long as you are healthy and the condition is

under control, it is very likely you will be • Can I give blood if I'm diabetic? Diabetics may donate blood

as long as the other medical requirements

• Can I give blood if I'm anemic? Your hemoglobin (iron) level will be checked prior to donating blood. As long as levels are normal (12.5 is an acceptable level) on

the day of donation, you may give. Can I give blood if I had cancer? While some types of cancer

may disqualify you from donating, there are many circumstances under which you may donate blood after an appropriate waiting period.

• Can I give blood if I have seasonal allergies? Allergies, even those that need to be controlled by medication, will not prevent you from donating blood.

• Can I give blood if I had a flu shot? In fact, you may donate blood the same day you receive the vaccination.

• Can I give blood if I have epilepsy or seizures? Epilepsy or seizures do not disqualify you from donating as long as you have had no seizures for one year.

Early History Thoughts!!

The first recorded deed for the Wadesboro Methodist Church was in

1832. The church was in a very small wooden building located on the property near Wadesboro Lumber (the former Crawford Motor Company). The next church building was built in 1891 on the corner of Greene and Morgan Streets. This was directly across the street from the Kilwinning Masonic Lodge that had been built some years prior (circa The South Carolina Methodist served the area, covering the territory

from Charleston, SC up through this area to include part of Mecklenburg County and part of Virginia - all meeting in the Kilwinning Lodge building across the street - it being the largest place to cater to the delegation at that time. In later years, while the Wadesboro Presbyterian Church was in their

building program, they had Sunday School in the downstairs rooms until he completion of their facility.

Many years later on January 15, 1961, Bishop Paul Harding came to Wadesboro for the opening of the then newly built First Methodist Church with Rev. Moody Nifong, the minister (both now deceased). Lots of history from just a 'small bit' of the area.

Avoid Burning During Period of Increased Fire Risk

The NC Forest Service is urging residents to be safe and avoid burning yard waste and other debris until the state gets some significant rain. Humidity levels across the state are low, and projected increases in moisture may not be enough to prevent fuels from igniting if a careless ember lands among forest debris. There have been nearly 600 wildfires across the state in November, according to Forest Service statistics. Debris burning is the No. 1 cause of

wildfires in North Carolina. Individuals who determine that burning debris is a necessity should contact their county forest ranger. The ranger can offer technical advice and explain the best options to maximize

the safety of people, property and the forest. "Protect our natural resources by acting safely; don't burn on dry, windy days, and maintain a careful watch over a fire until it is extinguished," said Agriculture Commissioner Steve Troxler.

The Forest Service urges people who choose to burn debris, to adhere to the following tips: Make sure you have a valid burning permit, which can be obtained at any N.C. Forest Service office or authorized permitting agent, or online at ncforestservice.gov.

• Check with your county fire marshal's office for local laws on burning debris. Some communities allow burning only during specified hours; others forbid it entirely.

• Check the weather. Don't burn on dry, windy days.

• Some yard debris, such as leaves and grass, may be more valuable if composted. Burn natural vegetation only. Burning household trash or any other man-made materials is

illegal. Trash should be hauled away to a convenience center. • Plan burning for the late afternoon when conditions are typically less windy and more humid.

• Be prepared. Have a shovel or hoe to clear a perimeter around the burn area. • For fire control, you will need a hose, bucket, a steel rake and a shovel for tossing dirt on the fire.

• Never use flammable liquids such as kerosene, gasoline or diesel fuel to speed debris burning.

• Stay with the fire until it is completely out. • Never dump hot ashes or coals into a wooded area. Instead, douse burning charcoal or

campfires thoroughly with water; stir the coals and soak them again. Be sure they are extinguished.
