Mr. Roger Barrett Breitreuz, 65, died Saturday, December 16, 2017, at Hospice Haven of Richmond County.

Roger was born in Elizabeth, New Jersey, on August 27, 1952, a son of the late Harry Herman Breitreuz and Melvina Barrett Breitreuz. He graduated high school and went immediately into the US Army where he served several tours of duty overseas, including Vietnam. Roger was always proud of being a veteran of the US Army.

Roger moved to North Carolina in 1994 where he fell in love with the people and the land. He had worked for several local farmers and enjoyed being outdoors. Roger was an animal lover and gave many stray animals a home. He was a great supporter of the local chapter of the Humane Society.

Mr. Abner Milton Cornwell, Jr.

Mr. Abner Milton Cornwell, Jr. of Wadesboro died on November 12, 2017, at Carolinas Medical Center-Union in Monroe, following a brief illness.

A private memorial was held at Sullivan Place on December 17, 2017, with interment preceding the service in Eastview Cemetery. Services were conducted by Rev. Dr. Sarah B. Kalish and Rev. Tom Kakadelis.

Born in Lincolnton, NC on January 24, 1930, he was the son of Dr. Abner Milton Cornwell, Sr. and Mary Anne Newcomb Cornwell.

After graduating from Lincolnton High School he attended Oak Ridge Military Academy and then the University of North Carolina at Chapel Hill where he received a BA degree in geography.

Milton served in the 8th Infantry Division of the US Army during the Korean conflict, and was stationed primarily at the Army's Cold Weather and Mountain Training Center in Fort Carson, Colorado Springs,

CO. After military service he returned to Chapel Hill and attended the UNC School of Law, receiving his J.D. degree in 1959.

Milton practiced patent law with the Monsanto Company for 26 years, first with the Chemstrand Division in the Research Triangle Park area of North Carolina, and then with the parent company in St. Louis, MO. Retiring from Monsanto in 1985, he moved to Wadesboro and adopted it as home. For a short while, he practiced general law in Wadesboro.

He was a member of First United Methodist Church in Wadesboro, and taught the Wesley Bible Class for many years. While living in Chapel Hill he taught the men's bible class at University Methodist.

As co-proprietor of Sullivan Place Bed and Breakfast Milton not only was a gracious host, but also spent countless hours rehabilitating and beautifying the grounds of Sullivan Place. In his few leisure moments he enjoyed playing bridge with the Wadesboro Men's Bridge Club.

One of his greatest pleasures came from watching and identifying the many birds that came to the feeders outside his window. He especially enjoyed interacting with the family of cardinals that visited the feeders every day.

Survivors include his wife of 63 years, Nancy McQuague Cornwell of Wadesboro; daughter Dr. Nancy Cornwell Winker (Guyton) of Rutherfordton, NC; son Abner Milton Cornwell, III (Kathryn) of St. Louis, MO; five grandchildren,
