Anson County's Unemployment Rate 5.5% in October

Anson County's unemployment rate for October was 5.5%. In September the rate was 5.4%. Although the percentage went up slightly, there were actually more Ansonians employed in October than in September. The unemployment rate went up because there were slightly more people in the total labor force. Statewide the unemployment rate in October was 4.9%, up only slight from September's 4.8%.

Anson's total labor force in October was 10,904. Of that number 10,299 were employed and 605 were unemployed. In September the total labor force was 10,747, with

10,162 employed and 585 unemployed.

Unemployment rates (not seasonally adjusted) increased in 44 of North Carolina's counties in October, decreased in 22, and remained unchanged in 34. Robeson County nad the highest unemployment rate at 10.3 percent, while Buncombe County had the lowest at 3.6 percent. Six of the state's metro areas experienced rate increases, three decreased, and six remained unchanged. Among the metro areas, Rocky Mount at 7.2 percent experienced the highest rate and Asheville had the lowest rate at 3.8 percent. The October not seasonally adjusted statewide rate was 4.9 percent.

When compared to the same month last year, not seasonally adjusted unemployment ates decreased in 92 counties, increased in seven, and remained unchanged in one. Fourteen metro areas experienced rate decreases over the year and one increased.

The number of workers employed statewide (not seasonally adjusted) increased in October by $35{,}611$ to $4{,}659{,}304{,}$ while those unemployed increased $6{,}747$ to $237{,}804{.}$ Since October 2015, the number of workers employed statewide increased 133,693. while those unemployed decreased 22,796.

Insurance Commissioner and State Fire Marshal Wayne Goodwin announced that the Burnsville Fire and Rescue Ambulance Service, Inc. was awarded a \$6,086.00 grant through the 2016 Volunteer Rescue/EMS Fund from the State of North Carolina. The check will be mailed to Rescue Chief Josh Bowers to be used by this rescue/EMS

organization to purchase needed equipment. The equipment is purchased using matching funds and must be approved by the Department of Insurance Office of State Fire Marshal. 'Fire and rescue organizations protect our communities large and small across North Carolina, but sometimes their budgets don't grow with their responsibilities," Commissioner Goodwin said. "Our emergency service personnel should be supported with the best equipment and supplies needed to do their jobs correctly and safely

"I know the Burnsville Fire and Rescue Ambulance Service, Inc., will use this money to serve their community even better," Goodwin added. "Thank you, Chief Josh Bowers, for all of your hard work and thanks to your dedicated staff."

Burnsville Fire and Rescue Ambulance Service, Inc. has received a total of \$107,537.99 from the Volunteer EMS/Rescue Fund in the past 27 years since the program began. The General Assembly created the Volunteer Rescue/EMS Fund in 1989 to help volunteer units raise money for equipment and supplies. The grant funds must be matched dollar-for-dollar, up to an approved amount, by monies raised locally to purchase necessary equipment. Since the program's inception, the Department of Insurance has distributed \$29,628,435.63 to rescue and EMS squads across the state.

Wadesboro Tree Triming and Limb Removal Guidelines

The Town of Wadesboro provides the service to collect and dispose of tree trimmings and limb removal to the citizens of Wadesboro. The following rules apply The service is intended for homeowners who trim trees and shrubbery on their property

by the homeowner. The service is NOT intended for home owners that hire tree surgeons, contractors, etc. to cut trees/limbs and cuttings. • The Town will NOT remove trees/limbs, etc. from lot clearing operations.

Please limit the size of limbs to four inches in diameter and six feet long.

 Place the debris near the street, away from power poles or other obstacles. Do not place limbs in the ditches. Do not place debris where it blocks the view of traffic.


