This election year will provide some changes for voters across North Carolina and Anson County. Normally the Partisan Primary Elections are held in the month of May, however in 2016, the Primary Election will be held Tuesday March 15, 2016. In a primary voters who are registered Democrat, Republican or Libertarian will vote to select nominees to be placed on the General Election Ballot ( which will be held November 8, 2016). Unaffiliated Voters will have the option to choose which ballot they would like. (Democrat, Republican, Unaffiliated or Lib)
