#### **Area Church Suffers Extreme Vandalism**

Anson County Sheriff's Deputies are investigating the vandalism of a church in the northern part of Anson County. Deputies were called to the Cedar Hill AME Zion Church, on Springer road north of Ansonville around mid-day on Monday, November 14th. Officers found the church had been broken into and as Sheriff Tommy Allen said, "it was literally destroyed on the inside."

"On the inside of the church we found tables broken, ceiling fans broken, speakers pulled from the walls and thrown through the stained glass windows, chairs broken and thrown through windows, the podium destroyed, every window in the church broken out and graffiti spray painted all outside the church," Sheriff Allen said. Phrases such as God is a Lie, house of the devil, the n-word and f-word were spray painted on the church walls. A small cross from the pulpit was taken down and attempted to be burned at the church's front door.

"I've been around a long time and this is the worst case of vandalism and hate crime I've ever seen. This is not anything I've ever seen in Anson County before," Allen said. The Sheriff said he has asked the SBI to come in and assist his officers in the case

Also, Stanly County had six or seven similar vandalisms of churches reported yesterday (Monday) and a Rowan County church was vandalized. Detectives from Anson and Stanly have met and are working together as the cases are believed to have been committed by the same persons. Stanly County churches were both black and white churches.

## **Donald Davis Burr Sought** in Shooting of Bethany Horne

Anson County Sheriff's Deputies are looking for a suspect involved in a shooting incident in the early morning hours on Saturday, November 12th. Deputies were called to a Davis residence near the "Sugartown" intersection on US 742 North around 3:15 a.m. Sheriff Tommy Allen said that apparently a party had broken up and a confrontation between several individuals resulted in shots from a handgun



being fired into an occupied vehicle. The man doing the shooting had left the scene before deputies arrived. A woman inside the vehicle, Bethany Horne, was injured and taken by EMS to Union County Hospital. She had been shot in the head, fortunately only grazed by the bullet. Her condition was not life threatening and the she was treated and released.

**Donald Davis Burr** Deputies have warrants for the shooter, identified as Donald Davis Burr, III, age 29, for Shooting into an Occupied Vehicle and Possession of a Firearm by a Convicted Felon. Davis is also wanted for two counts of Probation Violation and Failure to Appear in court for a Possession of Methamphetamine charge.

## Wadesboro Police Officer Suspended by Chief Janie Schutz

A Wadesboro Police Officer was placed on leave by Police Chief Janie Schutz for what she referred to as improper disposal of meth lab materials. Schutz has also stated that the officer should have called her police department instead of the Sheriff's Office when he found the materials in question. She launched an internal investigation into the matter, and has asked the State Bureau of Investigation (SBI) to conduct an investigation. As of press time no known investigation has been undertaken on the matter by the SBI. In September a relative of the suspended officer brought several items that appeared to be have been a part of a meth lab to the officer at his home while he was off duty. The officer, who lives outside of the Wadesboro city limits, called the Sheriff's office and spoke with a detective, seeking information on what to do with the items, which included a plastic bottle and tubing. On advice from the Sheriff's detective the Wadesboro Police Officer disposed of the items. Chief Schutz has stated that the police officer should have called her police department, and that he should have handed the items over to the SBI for disposal. The bottle and tubing had been found in a home in Anson County and are believed to have belonged to a person who was already in jail on drug charges. Several days later more meth lab materials were discovered in the same home by occupants of that home, and the occupants contacted the Sheriff's Office. Among the family members in the home were children. Sheriff's Office personnel found more bottles, tubing, jars of acid, batteries and other items. Because these items were not a part of an operating meth lab, a Sheriff's detective advised the family in the home to dispose of the items themselves and wash the children's clothing in bleach. Despite the Wadesboro Police Chief's actions against her own officer for the way he disposed of the items, Sheriff Tommy Allen has defended his officers' recommendations for disposal of the materials in both cases, stating that neither the original incident with the suspended Wadesboro policeman nor the second incident of finding more materials involved an active meth lab.
